Agenda Item 3. Work Program for the Least Developed Countries

- 4. The Work Program for the Least Developed Countries Fund has been circulated to all Council Members as document GEF/LDCF.SCCF.29/03 and will be presented to Council for approval.
- 5. Draft Decision: The Council, having reviewed document GEF/LDCF.SCCF.29/03, Work Program for the Least Developed Countries Fund, approves the Work Program comprising of nine projects subject to comments made during the Council meeting and additional comments that may be submitted in writing to the Secretariat by January 11, 2021.

Total resources approved in this Work Program amount to \$63.87 million for the LDCF, inclusive of GEF project financing and Agency fees. The Work Program is comprised of the following Project Identification Forms (PIFs):

With respect to the PIFs approved as part of the Work Program, the Council finds that each of these PIFs (i) is, or would be, consistent with the Instrument and GEF policies and procedures, and (ii) may be endorsed by the CEO for final approval by the GEF Agency, provided that the final project documents fully incorporate and address the Council's and the Scientific and Technical Advisory Panel (STAP) reviewer's comments on the Work Program, and that the CEO confirms that the project continues to be consistent with the Instrument and GEF policies and procedures.

With respect to any PIF approved in this Work Program, the final project document will be posted on the GEF website for information

after CEO endorsement. If there are major changes to the project objectives or scope since PIF approval, the final project document shall be posted on the web for Council review for four weeks prior to CEO endorsement.

Agenda Item 4. FY19 Annual Monitoring Review of the Least Developed Countries Fund and the Special Climate Change Fund

- 6. The Annual Monitoring Review (AMR) of the Least Developed Countries Fund and the Special Climate Change Fund has been circulated to all Council Members as document GEF/LDCF.SCCF.29/04 and will be presented to Council for approval.
- 7. The AMR describes the performance and results of, and the lessons learned from the portfolio of projects and programs financed under the Least Developed Countries Fund (LDCF) and the Special Climate Change Fund (SCCF) that had begun implementation on or before June 30, 2019 and that were under implementation during at least part of the fiscal year 2019 (FY19). The review further provides information on management effectiveness and efficiency as it relates to the LDCF and the SCCF.

- 1) The LDCF/SCCF Council, having reviewed document GEF/LDCF.SCCF.29/04, FY19 Annual Monitoring Review of the Least Developed Countries Fund and the Special Climate Change Fund, welcomes the review and appreciates the progress made in reporting portfolio-level performance, results and lessons learned under the LDCF and the SCCF.
- 2) The Council welcomes the overall finding that the LDCF and SCCF portfolio under implementation in FY19 performed satisfactorily.
