**PROGRESS REPORT ON THE LEAST DEVELOPED COUNTRIES FUND
AND THE SPECIAL CLIMATE CHANGE FUND**

Recommended Council Decision

The LDCF/SCCF Council, having reviewed document GEF/LDCF.SCCF.29/05 *Progress Report on the Least Developed Countries Fund and the Special Climate Change Fund*, welcomes the report and takes note with appreciation of the progress made under the LDCF and the SCCF.

EXECUTIVE SUMMARY

1. This report provides an update on the progress made in the operations of the Least Developed Countries Fund (LDCF) and the Special Climate Change Fund (SCCF) during the reporting period between November 1, 2019 and October 31, 2020. The financial status updates are of September 30, 2020.
2. As of September 30, 2020, total cumulative pledges and contribution agreements to the LDCF amounted to \$1,597.62 million. Of this amount, \$1,495.04 million, or approximately 94 percent, had been received. Cumulative LDCF funding decisions by the LDCF/SCCF Council and the CEO amounted to \$1,529.48 million. Resources available for new funding decisions amounted to \$82.45 million.¹ Since its inception, the LDCF has approved 305 projects, including 24 multi-trust fund projects (MTFs).²
3. The LDCF received approximately \$27.36 million in new pledges during the reporting period from Belgium, Finland, Iceland, Ireland and Switzerland. Contributions received during the reporting period totaled \$151.09 million, from Belgium, Denmark, Finland, Germany, Iceland, Ireland, Netherlands, Sweden, and Switzerland.
4. During this reporting period, 17 LDCF Full-Sized Projects (FSPs), including five MTFs with the GEF Trust Fund, were approved by the LDCF/SCCF Council as two Work Programs. Eight Medium-sized Projects (MSPs), including three MTFs with the SCCF, were approved by the GEF CEO. Ten LDCF projects, including one MTF with the GEF Trust Fund, were CEO endorsed for implementation. Annex I presents a full list of approved LDCF projects and programs to date.
5. Nine projects requesting a total of \$63.87 million from the LDCF are being presented to the 29th LDCF/SCCF Council in December 2020 for approval.^{3, 4} The Work Program constitution follows the operational improvements agreed by the 24th LDCF/SCCF Council in June 2018, as stipulated in the GEF Programming Strategy on Adaptation to Climate Change.⁵
6. As of October 31, 2020, 51 least developed countries (LDCs) had accessed approximately \$12.20 million in support of the preparation of national adaptation programs of action (NAPAs). LDCF support toward national adaptation planning (NAP) processes totaled \$61.45 million as at October 31, 2020.⁶ This support includes projects that explicitly seek to advance NAP processes

in countries, in addition to technical assistance for tailored one-on-one support through the LDCF-financed NAP Global Support Program. Notably, several projects combined requests for funding to support NAP processes with requests to support concrete adaptation investments for NAPA implementation. Global projects amounting to \$13.69 million had been approved to support the NAP preparation process in LDCs, and the implementation of elements of the LDC work programme other than NAPAs.

7. The LDCF portfolio seeks to reduce the vulnerability of nearly 23 million people. Also, 95 LDCF projects are supporting countries in their efforts to integrate climate change adaptation into 367 national development policies, plans and frameworks. The LDCF further assists countries in laying the groundwork for climate-resilient development through 88 projects that enable countries to strengthen their national climate information services network.

8. During this reporting period, the Secretariat completed consultations with 17 countries with technically cleared project(s) in the GEF-6 LDCF pipeline to ascertain the viability of these projects in alignment with the respective countries' current priorities for LDCF support. With the approval of the December 2020 LDCF Work Program, all of these 17 countries will have successfully accessed LDCF resources in GEF-7.

9. As for the SCCF, cumulative pledges amounted to \$356.09 million as of September 30, 2020. Of the total resources pledged, \$349.44 million or approximately 98 percent had been received. Cumulative SCCF funding decisions by the Council and the CEO amounted to \$361.93 million.⁷ Since its inception, the SCCF has approved support for 87 projects, including 16 MTFs.⁸

10. While no new pledges were made during the reporting period, SCCF contributions totaling \$0.83 million were received from Switzerland.

11. During the reporting period, seven MSPs, including three MTFs with the LDCF, were approved by the CEO for \$7.06 million of GEF project financing and Agency fees. No Full-Sized Projects or Programs were submitted during the reporting period, and none were approved.

12. The SCCF projects aim to directly reduce the vulnerability of nearly 7 million people.

13. The Challenge Program for Adaptation Innovation continued to make progress during the reporting period. Following the announcement of nine finalists in December 2019, the concepts were developed as MSPs and approved by the CEO. One project is under implementation. Three projects are supported by the LDCF, three by the SCCF, and three are LDCF-SCCF MTFs, with \$4.82 million from the LDCF and \$4.87 million from the SCCF, including GEF project financing and Agency fees.

INTRODUCTION

1. This report provides an update on progress made in the operations of the Least Developed Countries Fund (LDCF) and the Special Climate Change Fund (SCCF) since the inception of the two funds, as well as specific activities during the reporting period of November 1, 2019 to October 31, 2020. Table 1 below presents a summary of LDCF and SCCF operations, including total cumulative pledges, paid contributions, and project approvals.
2. Due to time constraints, the GEF Secretariat did not submit the Progress Report on the LDCF and SCCF at the virtual 28th LDCF/SCCF Council in June 2020. This document fills this gap and reports on activities undertaken by the GEF Secretariat since the last report was presented to the 27th LDCF/SCCF Council held in December 2019.

3. As the GEF continues to adapt to the evolving impacts the COVID-19 crisis is having on its business, a set of issues have been identified and specific actions have been incorporated in the different phases of the project review cycle of the GEF Trust Fund and LDCF-SCCF projects. These actions have been developed and continuously updated in active consultation within the

GEF Partnership to mitigate COVID-19 risks and ensure efficient and effective design and implementation of LDCF and SCCF resources. One of the actions taken is the CEO has provided a universal extension of six months to the current 8- and 12- month deadline for submission of Medium-Sized Projects (MSPs) and Full-Sized Projects (FSPs), respectively, as well as the 12- and 18-month deadline to receive actual CEO endorsement/approval. The effect of these extensions on the LDCF and SCCF portfolio is described in this report.

4. Since June 2020, the GEF Partnership has also been investigating opportunities and taking actions to ensure GEF investments in climate adaptation contribute to addressing the full effect of the COVID-19 pandemic. This includes analyzing and integrating pandemic associated risks, impacts and opportunities into the business of the LDCF and SCCF. The December 2020 LDCF Work Program presented to the 29th LDCF/SCCF Council meeting reflects these actions.¹⁵

5. The LDCF and SCCF will continue to deepen its investment in opportunities to mitigate impacts of COVID-19 to deliver climate adaptation and resilience benefits and contribute toward green recovery and building back better.

LEAST DEVELOPED COUNTRIES FUND

Pledges and Contributions to the LDCF

6. As of September 30, 2020, cumulative pledges to the LDCF amounted to \$1,597.62 million. Of the resources pledged, \$1,495.04 million or about 94 percent had been received. As of September 30, 2020, LDCF resources available for funding decisions amounted to \$56.09 million. Additional contributions of \$25.90 million were also received between October 1 to November 10, 2020, according to the Trustee. In total, approximately \$82 million were available for the December 2020 Work Program.

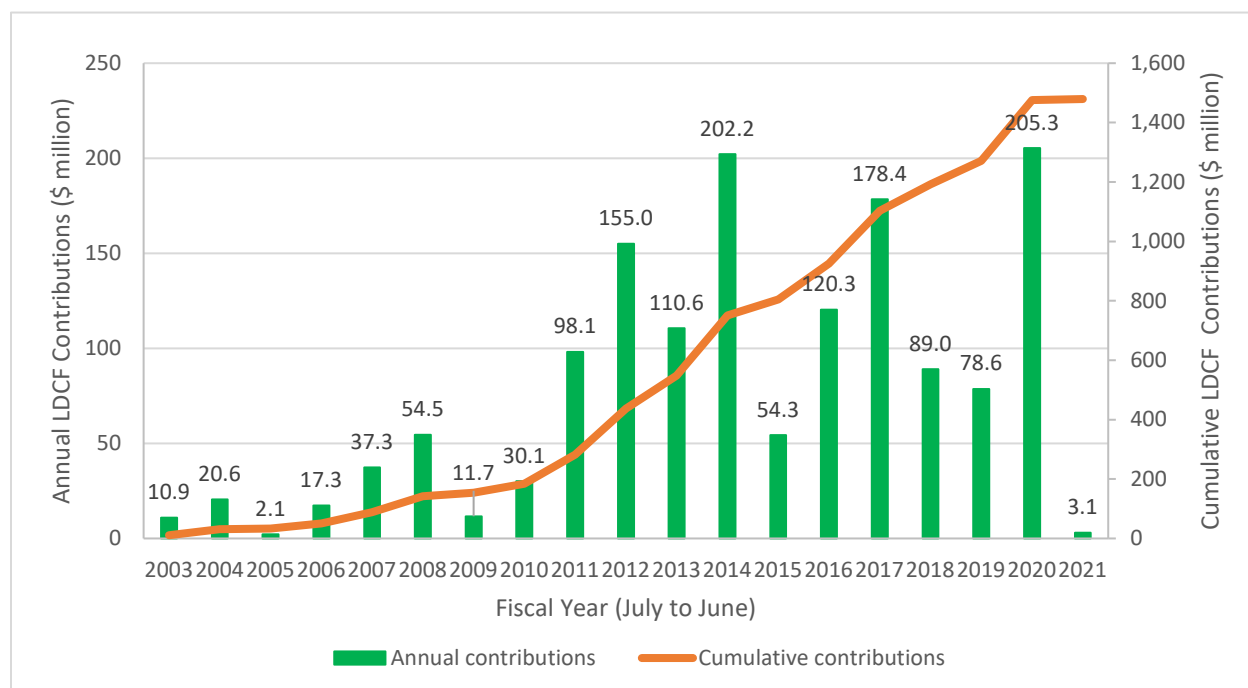
7. A total of \$27.36 million in new pledges were made during the reporting period by Belgium, Finland, Iceland, Ireland, and Switzerland. Paid contributions totaling \$151.09 million were received from Belgium, Denmark, Finland, Germany, Iceland, Ireland, Netherlands, Sweden, and Switzerland. Annex V presents Trustee information.

8. Figure 1 shows total annual LDCF contributions finalized per each fiscal year and cumulative contributions.¹⁶ Fiscal year 2020 has had the highest level of annual contributions finalized since the LDCF was established, at \$205.3 million.

Progress in LDCF Operations

9. During the reporting period, 25 projects were approved. Among them, 17 projects were approved by the LDCF/SCCF Council as two Work Programs, for a total of \$119.54 million of GEF project financing and Agency fees. Of these 17 projects, nine were approved in the December 2019 Work Program for a total of \$59.95 million, including GEF project financing and Agency fees. An additional eight projects were approved as part of the June 2020 Work Program for a total of \$59.59 million. These Council-approved projects included five MTFs with the GEF Trust Fund. In addition, eight Medium-Sized Projects (MSPs) were approved by the CEO with \$9.17 million in project financing and Agency fees from the LDCF. Three of these MSPs are MTFs with the SCCF. Annex I presents a list of approved LDCF projects and programs and their status. Projects approved during the reporting period are also included and marked in Annex I.

10. Nine LDCF projects requesting \$63.37 million for GEF project financing and Agency fees¹⁷ are presented to the 29th LDCF/SCCF Council for its consideration as part of the December 2020 LDCF Work Program.¹⁸ This is the fifth Work Program to be considered by Council since transitioning to the Work Program model based on operational improvements introduced in the GEF-7 period, as per the GEF Programming Strategy on Adaptation to Climate

Change.¹⁹ The overall statistics of projects considered for the December 2020 LDCF Work Program is presented in Table 2.

11. For the GEF-7 period, the number of initiatives approved by the LDCF totals 51, comprising of 49 projects and two programmatic approaches, for \$338.06 million in LDCF resources.²¹ Of these, 43 have been approved by the LDCF/SCCF Council, and eight were approved by the CEO as MSPs. Approximately 27 percent of these projects are MTFs, with ten FSPs, one programmatic approach, and three MSPs.

12. Figure 2 presents the total annual and cumulative LDCF funding approvals by fiscal year, inclusive of the GEF project financing, Agency fees, PPGs, and PPG fees.²²

13. As of October 31, 2020, the GEF, through the LDCF, has provided \$12.20 million in support of the preparation of National Adaptation Programs of Action (NAPA).²³ South Sudan was the last country to submit its NAPA to the United Nations Framework Convention on Climate Change (UNFCCC) in 2017, bringing the total number of countries that had completed and submitted their NAPAs to 51.²⁴

14. A total of \$1,529.48 million has been approved for LDCF projects, including the preparation of NAPAs. Of the total, 260 projects support NAPA implementation, the national adaptation plan (NAP) process, and other elements of the LDC work programme. These figures include three global projects with LDCF resources amounting to \$13.69 million approved to support the preparation of the NAP process in LDCs, and the implementation of elements of the LDC work programme other than NAPAs. As an example of support to the LDC work programme implementation, a project to build endogenous capacity titled “Strengthening Endogenous Capacity of Least Develop Countries to Access Finance for Climate Change Adaptation” was approved during the reporting period.

15. In addition to financing the urgent and immediate adaptation needs of LDCs and the LDC work programme, the LDCF is also mandated to support the NAP process, which is an iterative and ongoing process encapsulating medium and long-term planning for adaptation.²⁵ As of October 31, 2020, total funding from the LDCF toward LDCs’ NAP processes amounts to \$61.45 million. This includes projects in Bangladesh, Chad, Democratic Republic of the Congo, Djibouti, Lao PDR, Niger, Rwanda, São Tomé and Príncipe, Senegal, South Sudan, and Timor Leste. During the reporting period, a project was approved in Djibouti with activities contributing toward the in-country NAP process. GEF support for NAPs in the GEF-7 period focuses on the implementation of NAP priorities, as well as additional analysis that may be needed to better align GEF proposals with the NAP framework.

16. These projects enable countries to move more effectively towards the integration of climate change adaptation considerations across key policies, plans, programs and decision-making processes, in line with guidance from the Conference of the Parties (COP) to the UNFCCC,²⁶ as well as a LDCF/SCCF Council decision to operationalize support towards NAP process.²⁷

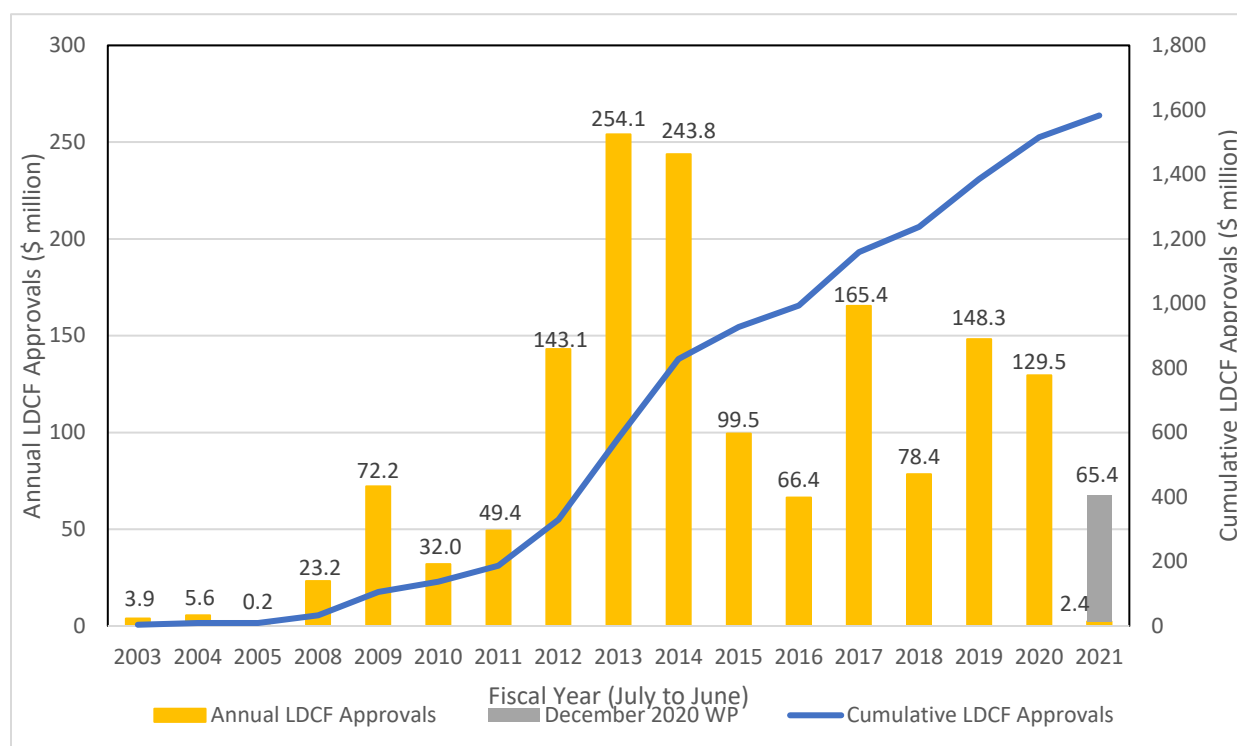
17. Each project approved during this reporting period or presented for the LDCF/SCCF Council consideration articulates its national priorities and alignment with the NAPA and NAP processes. All 47 LDCs currently eligible for LDCF support has had at least one NAPA implementation project approved under the LDCF. Some LDCs are also utilizing the LDCF resources in the GEF-7 period to support NAP implementation.

LDCF Resource Access for GEF-7 Period

18. For the GEF-7 period starting on July 1, 2018, an initial resource access cap was introduced, under which each LDC can draw up to \$10 million in LDCF resources toward the \$50 million cumulative ceiling during the GEF-7 period.²⁸ The rationale behind the introduction of the cap is to ensure more timely access to resources by as many LDCs as possible, while also maintaining the practice of equitable access. Cumulatively, each LDC is eligible to access up to \$50 million from the LDCF (see Table 3).

19. Upon approval of the December 2020 LDCF Work Program, 23 LDCs, or 49 percent of LDCs, have accessed the full initial \$10 million cap for the GEF-7 period. Fifteen more LDCs, or 38 total (81 percent), have successfully accessed LDCF resources since the beginning of GEF-7. The two Work Programs approved during the reporting period included countries with low utilization of LDCF resources to date, such as Guinea, Liberia, Myanmar, South Sudan and Yemen. The December 2020 Work Program also includes countries with low utilization, such as Burundi.

Agency Involvement in LDCF Projects

20. During the first two years of the GEF-7 period, eleven GEF Agencies have been engaged in LDCF programming. The United Nations Development Programme (UNDP) has \$119.90 million, or 34.7 percent of the GEF-7 cumulative programming volume, followed by Food and Agriculture Organization (FAO) at \$95.24 million or 27.6 percent. African Development Bank (AfDB) has the third 13 highest share of 11.3 percent at \$38.97 million, followed by the United Nations Industrial Development Organization (UNIDO) at \$22.04 million, or 6.4 percent. The Agency involvement in the GEF-7 period shows a different, more balanced trend compared to the Agency programming distribution since the LDCF inception, described below.³¹

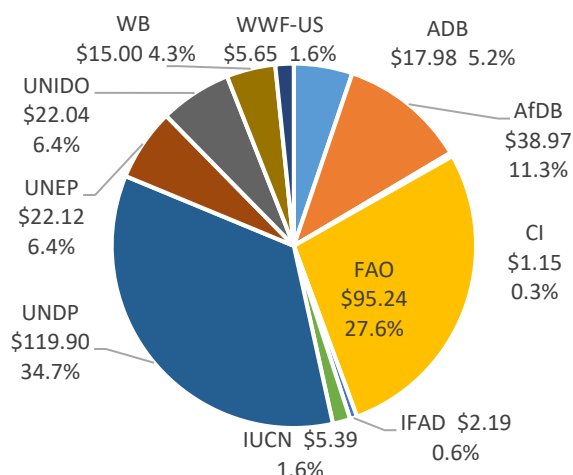
21. Since the LDCF inception to September 30, 2020, eleven GEF Agencies have been involved in LDCF projects and programs. According to the GEF Trustee Report, UNDP has the largest share of project funding approvals, with 49.4 percent; followed by FAO at 13.7 percent and UNEP at 12.6 percent, as shown in Figure 3. Other GEF Agencies implementing LDCF projects are AfDB, World Bank, International Fund for Agricultural Development (IFAD), ADB, International Union for Conservation of Nature (IUCN), Conservation International (CI), and UNIDO.³²

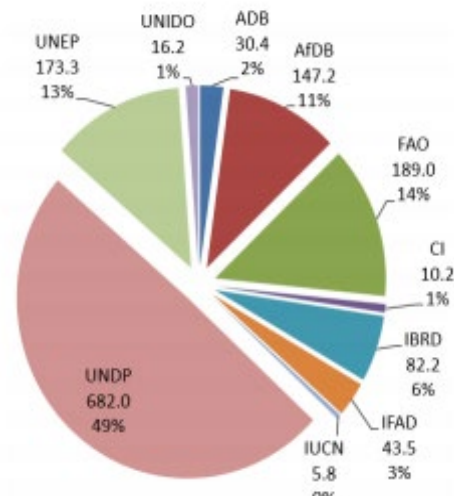

CEO Endorsements

22. During the reporting period, ten LDCF projects, including one MTF with the GEF Trust Fund, were endorsed by the GEF CEO, for \$61.61 million in GEF project financing (see Table 4). Nine of these projects are from the GEF-6 period, while one project is from GEF-7.

23. These projects fall under the old GEF Project Cancellation Policy, which states that all FSPs that received PIF approval prior to March 1, 2019 must submit their CEO endorsement request within eighteen months of Council approval.

24. All ten projects met their submission deadline under the old Cancellation Policy to submit the full project proposal within eighteen months of PIF approval, ranging from 15 to 18 months. The time between the PIF approval and the CEO endorsement ranged from 18 months for the GEF-7 project to 42 months for one GEF-6 project. On average, these projects took 2 years and 8 months from the PIF approval to the CEO endorsement.

25. From March 1, 2019 onwards, the revised Project Cancellation Policy has been applied to improve the operational efficiency of the GEF.³³ If a FSP is not submitted for CEO endorsement within twelve months of the date of Council approval or if it has not been CEO endorsed after eighteen months, the project may be subject to cancellation. Projects approved in the June 2019 LDCF Work Program and thereafter fall under the revised Cancellation Policy.

26. In response to the COVID-19 pandemic, the CEO granted a total of six-month extension on all project deadlines.³⁴ Almost all GEF-7 projects that fall under the revised Cancellation Policy have exercised the extension granted by the CEO. Several projects that fall under the old Cancellation Policy have submitted their CEO endorsements during extension period.

27. This extension may increase the average time for CEO endorsements and impact the expected improvement on project cycle timelines, while it has provided additional time for project development and prevented cancellations.

28. The full impact of the COVID-19 pandemic on the LDCF portfolio will become more apparent over time. The GEF Secretariat will continue to monitor this and report any findings in following progress reports.

Expected Results under the LDCF

29. As of the end of this reporting period, 237 LDCF projects had been CEO endorsed or approved, of which 113 have already been implemented and completed. Of these, 197 projects support NAPA implementation, the NAP process, and the implementation of other elements of the LDC work programme.³⁵ In total, 169 out of 197 implementation-oriented projects that have been CEO endorsed or approved provided an estimate of the number of direct beneficiaries. Key expected results of these projects, including aggregate values of quantitative indicators, are summarized in Table 5 below.

30. These indicators are aligned with the results framework that was introduced in the GEF Programming Strategy on Adaptation (2014-2018) and refined in the updated results architecture for the LDCF and SCCF and apply to projects submitted for CEO endorsement during the GEF-6 period.³⁶ Full expected results can be found in the results frameworks specific to each project, available in the project documents posted on the GEF website.³⁷

31. In response to the request made at the 14th LDCF/SCCF Council in June 2013, the GEF Secretariat, in its Annual Monitoring Review (AMR) of the LDCF and the SCCF, continues to provide a summary of actual, portfolio-level results of projects that have been completed or that are under implementation. The most recent AMR, reporting results from the 2019 fiscal year will be presented at the December 2020 LDCF/SCCF Council.³⁸

32. The GEF's active portfolio of CEO-endorsed or approved projects in various stages of implementation seek to directly reduce the vulnerability of nearly 23 million people. Within this cohort of CEO endorsed projects, nearly every project reported 50 percent of beneficiaries being women. Given the mandate of the LDCF to support the preparation of the NAP process in LDCs, 95 LDCF projects are already supporting countries in their efforts to integrate climate

change adaptation into 367 regional, national and sector-wide policies, plans and frameworks. The LDCF also assists countries in laying the groundwork for climate-resilient development through 86 projects that will enable countries to strengthen their national climate information services network.

The following are examples of projects that were CEO endorsed during this reporting period, with a brief description of their expected results and impacts.

33. *Sustainable Natural Resources Management Project* (GEF ID 10083); Agency: World Bank; LDCF project financing: \$4.57 million; co-financing: \$10.00 million. This multi trust fund (MTF) project with support from the LDCF and the GEF Trust Fund builds on the GEF-5 Great Green Wall South Sudan Natural Resources Management (GGW-SSNRMP) project in Sudan, and aims to advance the best practices of the GGW in two important districts Khartoum and

Gadarif. This new project provides a new focus on climate resilience of vulnerable communities through sustainable land management, climate resilient agriculture and alternate livelihoods for improved adaptive capacity. The project has also given due consideration to the COVID-19 pandemic in Sudan and has proposed flexibility to address relevant requests by Government of Sudan to support activities to fight coronavirus that align with project's focus on strengthening resilience of communities. In line with GEF-7's integrated approach, the multi-trust funding enables the project to take a holistic and integrated natural resources management approach to link climate change adaptation activities in support of combating land degradation in the target sites. The joint programming allowed the project to improve management of more than 90,000 hectares of land to reduce land degradation and managed for climate resilience, and also directly benefit 52,500 climate vulnerable people in the target districts.

34. *São Tomé and Príncipe Additional Financing - West Africa Coastal Area Resilience Investment Project* (GEF ID 9364); Agency: World Bank; LDCF project financing: \$6,000,000; co-financing: \$8,400,000. The project will remove key barriers in adaptation to climate change in the fishery sector and build resilience through capacity development in coastal zone monitoring and investments in green infrastructure and will mainstream policy reforms. It will also improve the early warning systems and Safety at Sea Program among artisanal fishers. The project will directly benefit 130,000 people (over 50 percent women), support the climate resilient management of 120 ha of land, mainstream climate resilience in five policies and plans, and train 4,740 people on climate risks and adaptation. The LDCF resources will be used to support the following components:

Results in GEF-7

35. In the GEF-7 period, the Updated Results Architecture for the LDCF and SCCF introduced a set of four Core Indicators that LDCF/SCCF projects are expected to track and report, in alignment with the Updated Results Architecture for the GEF Trust Fund.^{39, 40} These LDCF/SCCF Core Indicators are requested at Project Information Form (PIF) or CEO Approval submission stage, and subsequently at CEO Endorsement, mid-term, and terminal stages. Applicable new reporting features of the GEF Trust Fund for GEF-7, such as the provision of meta-information for projects by Agencies, are also applied to the LDCF/SCCF results framework. The LDCF/SCCF Core Indicators, listed below, contribute to a section of the GEF Scorecard, focused on adaptation to climate change:

- i. Number of direct beneficiaries (gender-segregated, male/female)
- ii. Number of hectares of land under climate-resilient management
- iii. Number of policies, plans and development frameworks that mainstream climate resilience

- iv. Number of people with enhanced capacity to identify climate risk and/or engage in adaptation measures (gender-segregated, male/female).

36. The expected contributions towards these Core Indicators from LDCF projects included in the December 2020 Work Program for approval by the 29th LDCF/SCCF Council are presented in the Work Program cover note.⁴¹

37. The GEF Policy on Gender Equality and GEF Policy on Stakeholder Engagement also apply to LDCF projects.⁴²

Consultations with Countries with GEF-6 Pipelined Projects

38. With the introduction of a new funding cycle for GEF-7, the 2018-2022 strategy recognizes the need to address the pipeline of technically cleared projects from GEF-6. At the time of technical clearance in GEF-6, these pipeline projects were deemed to address urgent and immediate adaptation needs in a country driven-manner. At the end of GEF-6, there were 21 technically cleared projects from 17 countries in the LDCF pipeline requesting a total of \$156 million from the LDCF.

39. As many of these projects had been queued in pipeline for over two years, the strategy stated that a reassessment of the relevance and timeliness of these projects was necessary, particularly taking into consideration its vision, as well as for pursuing renewed opportunities for integration and cross-cutting programming. The strategy further stated that the Secretariat would hold consultations with those countries with projects in the pipeline at the onset of the GEF-7 period.

40. The consultations, in alignment with broader GEF national planning, aimed to enable countries to develop a plan for LDCF support, in light of the new opportunities presented in the new GEF-7 adaptation strategy. The consultations offered countries opportunities to: (i) Seek more synergistic and harmonized programming with the GEF Trust Fund or other sources; and (ii) Re-evaluate whether and how their existing pipeline proposal(s) remain viable in terms of alignment with the national plan for GEF-7. Countries were then invited to develop or revisit and submit or re-submit proposals according to their respective national plans, which may or may not include updated proposals from the GEF-6 pipeline.

41. During the reporting period, the Secretariat continued to hold consultations with countries with remaining technically cleared projects in the GEF-6 LDCF pipeline, which are summarized in Table 6. Annex IV presents a summary of GEF-6 pipelined projects and outcomes based on consultations.

42. Based on the outcomes of these consultations, all 17 countries⁴³ with pipelined projects in GEF-6 have been consulted with regarding their GEF-6 pipelined projects, which have all either been updated or redesigned and approved thus far in GEF-7. Three are being presented in the December 2020 Work Program. The GEF Secretariat has completed consultations with all seventeen countries on the GEF-6 pipelined projects and have also successfully addressed the GEF-6 pipeline list. With the approval of this Work Program, all seventeen LDCs will have successfully accessed LDCF resources in GEF-7.

43. Additional consultations were also held with LDCs that do not have GEF-6 pipeline projects, in order to present the current strategy, discuss adaptation priorities, and to assist with programming. These consultations are typically held during GEF ECWs and other in-person opportunities. During the COVID-19 Pandemic, however, in-person discussions have paused.

SPECIAL CLIMATE CHANGE FUND

Pledges and Contributions to the SCCF

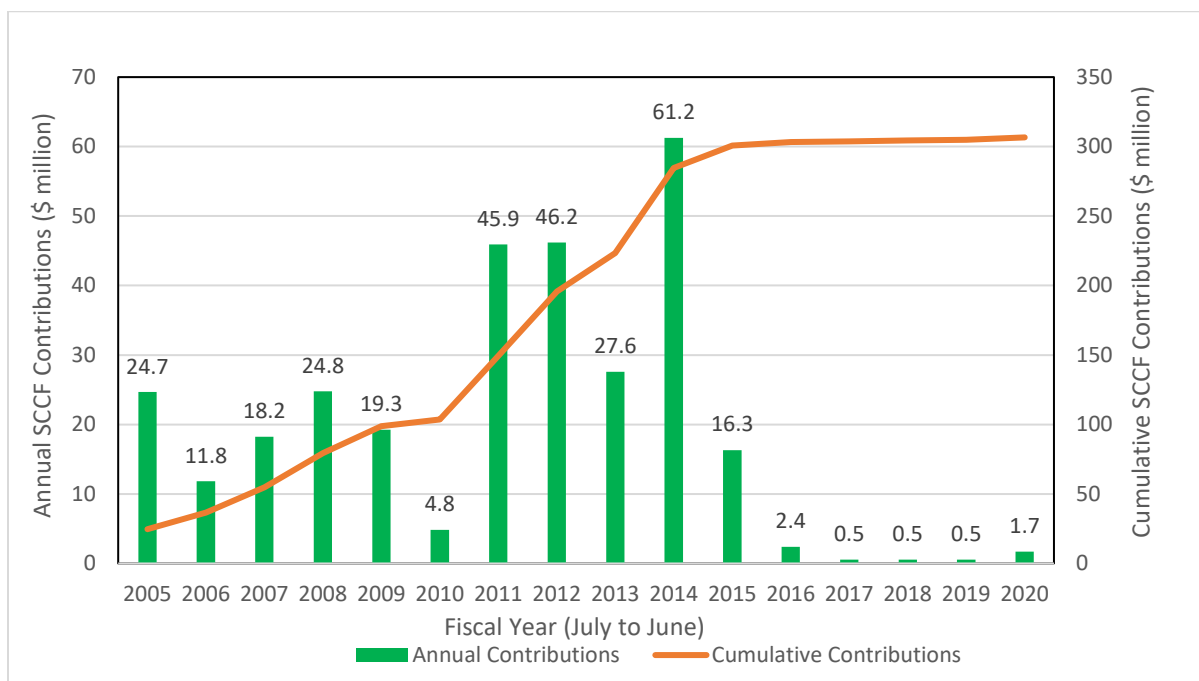
44. As of September 30, 2020, 15 donors pledged and signed Contribution Agreements or Contribution Arrangements amounting to \$356.09 million. The Trustee has received \$349.44 million in cash to date from these donors, 98 percent.⁴⁴ Figure 4 presents total annual and cumulative SCCF contributions finalized per fiscal year.

45. During the reporting period, SCCF contributions totaling \$0.83 million were received from Switzerland (see Annex V).

Progress in SCCF Operations

46. As October 31, 2020, cumulative funding decisions by the Council and the CEO amounted to a total of \$361.93 million, according to the Trustee report. Of the total amount approved, \$320.87 million was for projects and project preparation activities, \$31.46 million was for fees, and \$9.59 million was for administrative expenses and corporate activities of the SCCF.⁴⁵ There is a total of 87 projects approved under the SCCF.⁴⁶ Annex II presents a complete list of approved projects to date under SCCF-A and B. Figure 5 shows total annual and cumulative SCCF approvals by fiscal year, including GEF project financing, Agency fees, PPGs, and PPG fees.⁴⁷

47. For the GEF-7 period, the number of initiatives approved by the SCCF totals nine, comprising of one FSP and eight MSPs for \$10.21 million in SCCF resources.⁴⁸ Of these, one has

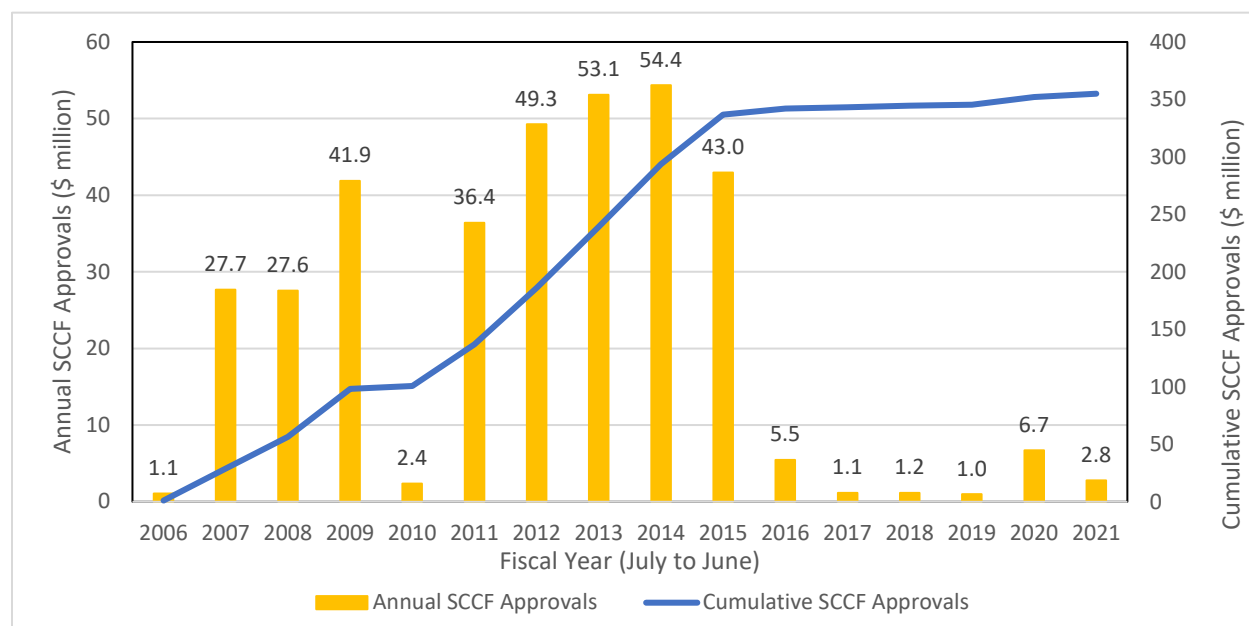

been approved by the LDCF/SCCF Council, and eight were approved by the CEO as MSPs. Approximately 44 percent of these projects are MTFs, accounting for four out of the nine projects.

Approvals and CEO Endorsements

48. Seven MSPs were approved by the CEO during the reporting period for SCCF resources of \$6.46 million in GEF project financing and \$0.60 million of Agency fees.⁴⁹ Six of these MSPs were approved as part of the Challenge Program on Adaptation Innovation, including one 1-step MSP. Of these, three are SCCF MSPs and three are LDCF/SCCF MTFs.

49. These projects approved are aligned with the current SCCF strategy, for which the Challenge Program for Adaptation Innovation is the primary entry point for Strategy Objective 1 of the GEF Adaptation Strategy 2018-2022 for the LDCF and the SCCF.⁵⁰

50. There were no SCCF FSPs or PFDs submitted, technically cleared, or approved by Council during the reporting period. There are no pending, deferred projects with SCCF support.

51. Among the nine GEF-7 projects with SCCF support, two have been CEO approved for implementation. As explained earlier, in response to the COVID-19 pandemic, the CEO granted a total of six-month extension on all project deadlines. Other seven GEF-7 projects fall under

the revised Cancellation Policy and have not yet reached the submission and/or approval deadlines due to the extension granted by the CEO.

52. During the reporting period, one project was CEO-approved as a one 1-step MSP as part of the Challenge Program. This project, as another SCCF MSP approved in this reporting period are presented below. A full list of these projects can be found in Annex II.

53. *Using Systemic Approaches and Simulation to Scale Nature-based Infrastructure for Climate Adaptation* (GEF ID 10632); Agency: UNIDO; SCCF Project Financing: \$2.00 million; Co-financing: \$3.56 million. The project aims to catalyze use of nature-based infrastructure by increasing certainty and predictability of natural asset's performance for climate adaptation. It will do so by strengthening design of methodologies to value economic and biophysical contributions of ecosystems services, incorporating system dynamics and finance modelling. The project will also enable the global update of these methods through global outreach partnerships and training. An innovative element is the collaboration with the MAVA Foundation, which is providing \$2 million co-financing, to scale the integration of nature-based infrastructure into climate adaptation plans, strategies, and projects globally. The project will address the critical barrier of limited understanding about nature value in providing adaptation results and will establish natural infrastructure as tangible and reliable assets for attracting public and private infrastructure investment. This investment is imbedded as an initiative of the Global Commission on Adaptation's Action Track on Nature-based Solutions, thereby strategically amplifying uptake of the methods developed by this project through the Commission's extensive influence. The project will directly benefit 115,000 climate vulnerable people and ensure 21,425 hectares of land are under climate resilience management.

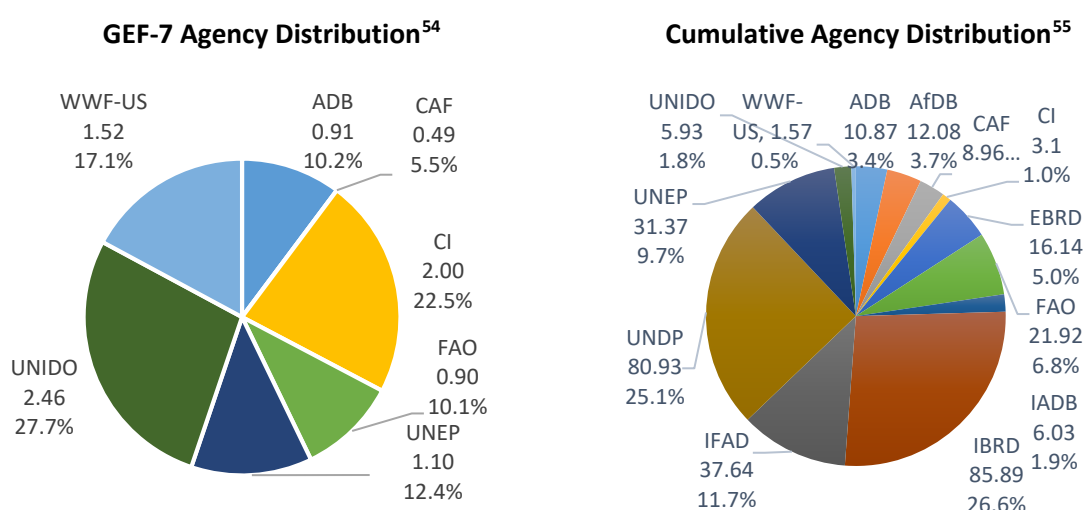
54. UAVs/drones for Equitable Climate Change Adaptation: Participatory Risk Management through Landslide and Debris Flow Monitoring in Mocoa, Colombia (GEF ID 10438), Agency: CAF; SCCF project financing: \$504,500, Co-financing: \$2.67 million. This project aims to advance equitable adaptation to climate change by reducing vulnerability through innovative technology development of Unmanned Aerial Vehicles (UAVs) for community-based landslide and debris flow monitoring and risk projection. The project will achieve its objective through the implementation of activities under three components: (i) Technological Infrastructure; (ii) Engagement and Local Capacity Building; and (iii) Knowledge Sharing Infrastructure and Data Applications. The project approach will strengthen local capacities to develop the necessary social and technological infrastructure for community-based, inter-agency landslide monitoring and risk reduction strategies. The project will increase the resilience of 20,300 persons to the impacts of climate change in a rural, mountainous community that has recently suffered tremendous devastation from a climate-related natural disaster. Through the building of local technical capacity and engagement by the project, the local community and authorities will be empowered to lead and manage their own Early Warning System (EWS) for excessive rainfall and mudslides, thus better preparing the community to adapt to the impacts of climate change. The proposed project leverages technological advances in these areas to implement a framework for innovative technology development of UAVs for community-based landslide monitoring leveraging MIT's hands-on education models and participatory approach to co-

develop and transfer technological capacities to Corpoamazonia. Lessons and technological tools resulting from this pilot project will be documented and disseminated through the partner's multi-scale network to contribute to the global conversation on the use of UAV's for equitable climate adaptation by providing clear guidance on the hardware, algorithm and model to engage local communities in technology related business opportunities.

Agency Involvement in SCCF Projects

55. As of September 30, 2020, thirteen GEF Agencies were involved in SCCF projects totaling \$322.43 million in project financing.⁵¹ The World Bank holds the largest share of the portfolio at 26.6 percent, followed by UNDP at 25.1 percent, 11.7 percent by IFAD, and 9.7 percent by UNEP.⁵²

Expected Results under the SCCF

56. By the end of the reporting period, 76 out of 87 SCCF projects have been approved⁵⁶ or endorsed by the CEO and are ready to begin implementation stage. Of these projects, 36 have already been implemented and completed.⁵⁷

57. Table 7 provides a summary of the quantitative results indicators from a critical mass of these projects. These indicators are aligned with the results framework that was introduced in the GEF-6 period, similar to the LDCF results.

58. Full expected results are detailed in the results frameworks specific to each project, available in the project documents posted on the GEF website.⁵⁸ In response to a request made at the 14th LDCF/SCCF Council in June 2013, the Secretariat, in its Annual Monitoring Reviews of the LDCF and the SCCF, continues to provide a summary of actual portfolio-level results of projects.⁵⁹

59. In total, 58 projects provided an estimated number of direct beneficiaries at the CEO endorsement/approval stage. These projects aim to directly reduce the vulnerability of close to seven million people. In addition, 35 SCCF projects are supporting countries in their efforts to integrate climate change adaptation into 145 national and sector-wide development policies, plans and frameworks.

60. In the GEF-7 period, the LDCF/SCCF follows the GEF policy for reporting on Core Indicators, as presented in detail in the Expected Results under the LDCF section. All projects approved in GEF-7 will report on the LDCF/SCCF Core Indicators and no longer on the indicators from the GEF-6 results.

MULTI-TRUST FUND PROJECTS (MTFs)

61. To date, there have been a total of 28 projects and six programmatic approaches that draw resources from multiple trust funds. Of these projects, five MTFs draw resources from both the LDCF and SCCF together, and 18 MTFs draw from the LDCF and GEF Trust Fund, while 10 MTFs are SCCF-GEF Trust Fund. One MTF draws resources from the GEF, the LDCF, and SCCF

62. Prior to GEF-7, different project approval processes and timing for the GEF Trust Fund and the LDCF/SCCF had an effect of limiting the number of MTFs. Projects that combined GEF Trust Fund and LDCF/SCCF resources often comprised components that were separately mapped to various thematic areas, rather than components that sought to integrate the them. The ambition for GEF-7 is to enable better integration and mainstreaming of climate change adaptation and resilience in GEF Trust Fund programming, especially in contexts where vulnerability to climate change is high.

63. Since the roll-out of the new LDCF/SCCF strategy and GEF programming directions in July 2018, the number of MTF proposals that support integration and seek synergy across different global environmental dimensions has increased. This ability to advance integration and mainstreaming of adaptation with support from multiple trust funds is a unique and positive feature of the GEF. The GEF Secretariat will continue its efforts to facilitate such

programming as appropriate, taking into consideration national needs, opportunities for systemic impact, and programming priorities.

64. Since the beginning of GEF-7, 15 MTF projects have been approved, as described in further detail in above sections.

65. One MTF project was CEO endorsed during the reporting period with resources from the LDCF and the GEFTF. The *Sustainable Natural Resources Management Project* in Sudan is described in the CEO endorsement section of the LDCF portion of this report.

CHALLENGE PROGRAM FOR ADAPTATION INNOVATION

66. Consistent with the GEF Programming Strategy on Adaptation to Climate Change, the GEF Secretariat announced a call for proposals for the Challenge Program on Adaptation Innovation in September 2019. The inaugural Call for Proposals for this Program was for a total of \$10 million in GEF support, resourced equally from the LDCF and SCCF.

67. The response to this call for proposals was highly positive. 388 concepts were submitted by 343 different organizations, with a total value of approximately \$550 million.⁶¹ Given the limited resources available, the Challenge Program was only able to select nine out of 388 of submissions (2.3 percent) to advance towards project concept development and approval. These nine concepts were invited by the GEF CEO and Chairperson to be considered for funding based on LDCF and SCCF standard guidance and procedures and were announced at COP 25 in December 2019.

68. The first progress report of the Challenge Program presented as an Information Document to the 27th LDCF/SCCF Council in December 2019.⁶² An update to this is presented as an Information Document for the 29th meeting of the LDCF/SCCF Council in December 2020, which includes details on the advances and impacts of each of the projects, both individually and as a cohort.⁶³

69. Since being announced at COP 25, all nine concepts have been developed and approved consistent with GEF policies and process. Eight have had their PIFs approved and one has been fully CEO Approved. The anticipated impacts through this Challenge Program are substantial, including in relation to the typical impacts scale of other LDCF and SCCF supported projects. The anticipated co-financing levels of these projects is also significant, even though co-financing is not a requirement of LDCF supported projects. Of the \$45.54 million in co-financing expected to

be catalyzed from the nine projects, \$29.88 million (65.6 percent) is anticipated from 12 different private sector partners.

70. Recognizing the pioneering nature of the nine projects in this program, numerous opportunities for synergies and knowledge sharing have been identified and acted upon during PIF approval and project development stages. These synergies and knowledge sharing efforts are being undertaken with a view to strengthen the differ and often complementary innovative aspects of each of the projects.

71. Initial progress made by the Challenge Program for Adaptation Innovation suggests it has strong potential to effectively address unmet needs for climate change adaptation innovation. In its first months, this program has been able to attract and engage partners and ideas that are currently unable to be met through conventional programming. Through the call for proposals modality that was open to any proponent whether or not they are a GEF Agency, the Challenge Program has been able to attract and engage partners that are new to the GEF, and unearth ideas that are currently unlikely to be brought to the GEF through the conventional programming. These partners include large-scale agriculture commodity managers such as Nespresso, commercial financial institutions such as the Agricultural Development Bank of El Salvador, SME fund managers such as South Pole Group, commercial insurance providers such as Willis Towers Watson, and municipal governments, as well as several SMEs and community organizations.

72. Recommendations to consider for further maximizing the impact potential of the Challenge Program for Adaptation Innovation include opening a second Call for Proposals prior to the end of GEF-7, subject to resource availability. A more complete set of recommendations are outlined in the aforementioned Information Document for the 29th LDCF/SCCF Council.
