Introduction

The information contained in this report is prepared based on financial information of the Special Climate Change Fund (SCCF) Trust Fund as of March 31, 2020.

The SCCF was established following the decision of the Conference of the Parties to the United Nations Framework Convention on Climate Change (the "UNFCCC") at its Seventh Session ("COP 7") in November 2001 to invite the Global Environment Facility ("GEF") to operate such a fund (Decision 7/CP.7 of the UNFCCC). At its May 15-17, 2002 biannual meeting, the GEF Council (the "Council") approved the arrangements proposed for the establishment of such a fund and invited IBRD to act as its Trustee (GEF/C.19/6).

Under the SCCF Trust Fund are the Program for Adaptation and Program for Technology Transfer, both of which have been established under the SCCF following the endorsement by the Council of such Programs on the basis of document GEF/C.24/12, Programming to Implement the Guidance for the Special Climate Change Fund adopted by the Conference of the Parties to the United Nations Framework Convention on Climate Change at its Ninth Session.

The report is produced by the Trustee in accordance with the Trustee's role as set forth in the paper entitled Arrangements for the Establishment of the New Climate Change Funds (GEF/C.19/6) which states:

"[...] the World Bank would be responsible for the financial management of each fund, including: [...] (iv) the preparation of financial reports regarding the investment and use of the funds' resources; and (v) regular reporting to the Council on the status of the funds' resources."

This report provides (i) a snapshot of the financial situation of the SCCF Trust Fund since its inception to March 31, 2020; (ii) the status of pledges and contributions, and (iii) the details of financial activities of the SCCF Trust Fund.

SCCF Trust Fund Financial Summary as of March 31, 2020

Pledges and Contributions:

As of March 31, 2020, 15 donors pledged and signed Contribution Agreements or Contribution Arrangements amounting to USDeq. 356.09 million, including USDeq. 294.76 million towards Program for Adaptation and USDeq. 61.33 million towards Program for Technology Transfer. The Trustee has received USDeq. 348.61 million in cash to date from these donors.

Investment Income:

As of March 31, 2020, the SCCF Trust Fund earned investment income of approximately USD 23.18 million on the undisbursed balance of the Trust Fund and USD 0.99 million as investment income from external agencies. The SCCF Trust Fund liquid portfolio has returned 0.35%¹ through the calendar year to March 31, 2020.

Funding Approvals and Trustee Commitments:

As of March 31, 2020, cumulative funding decisions by the Council and the CEO amounted to USD 358.58 million. Of the total amount approved, USD 318.64 million was for projects and project preparation activities, USD 31.14 million was for fees, and USD 8.8 million was for administrative expenses and corporate activities of the SCCF.

Funding approved by the Council and the CEO is committed by the Trustee and transferred following established procedures for all financial transactions as agreed between the Trustee and the Agencies. The Trustee has committed a total amount of USD 353.03 million, of which USD 313.44 million relates to projects and project preparation activities, USD 30.8 million to fees, and USD 8.8 million to cover corporate activities and administrative expenses.

Cash Transfers:

Cash transfers were made to Agencies on an as-needed basis to meet their projected disbursement requirements. Out of the cumulative commitments of USD 353.03 million, upon request from Agencies, the Trustee has transferred USD 299.52 million. The balance of USD 53.5 million remains payable as of March 31, 2020.

Funds Held in Trust and Funds Available for Council and CEO Funding Decisions:

Funds Held in Trust reflect financial activities related to new donor payments (cash and promissory notes), encashment of promissory notes, investment income, cash transfers, and the revaluation of the balance of promissory notes at month-end. Funds Held in Trust as of March 31, 2020 amounted to USDeq. 73.25 million.

<u>Funds available to support Council or CEO decision amounted to USD 14.2 million as of March 31, 2020</u>. This represents a net decrease of USD 1.16 million compared to funds available as of September 30, 2019. Fund transfers from October 1, 2019 to March 31, 2020 exceeded new funding approvals by the Council and CEO, receipt of new funds from donors and investment income earned during the same period.

The above table shows the total pledges and contributions to the SCCF. As of March 31, 2020, the Trustee had
entered into Contribution Agreements with 15 donors for a total contribution of USDeq. 353.61 million and has
received USDeq. 348.61 million in cash. In addition, an amount of USD 2.48 million has been pledged by
Switzerland, pending finalization of contribution agreement.

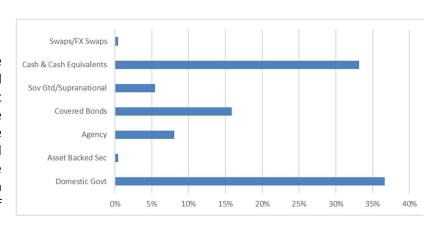

3. Asset Mix and Investment Income

ASSET MIX

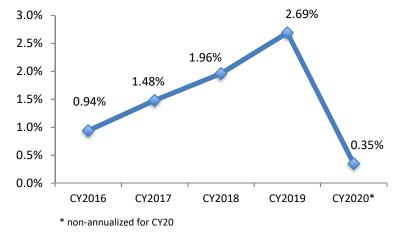
Funds held in trust by the World Bank (as the Trustee) are maintained in a commingled investment portfolio (the "Pool") for all trust funds administered by the World Bank. The assets in the Pool are managed in accordance with the investment strategy established for all trust funds administered by the World Bank. The chart reflects the asset mix of the portfolio in which SCCF funds are invested as of March 31, 2020.



INVESTMENT RETURNS

The SCCF funds are invested in accordance with the investment strategy established for all trust funds administered by the World Bank. Funds are managed such that the expected maximum loss, as measured by the Conditional Value-at-Risk (CVaR), at the portfolio's investment horizon, is not to exceed 1% with 99% confidence.

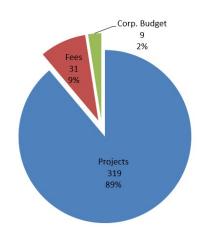
The SCCF Trust Fund liquid portfolio (which totaled approximately USD 73.25 million at end-March 2020) earned approximately USD 23.18 million in investment income since inception.

FUNDING DECISIONS BY ACTIVITY

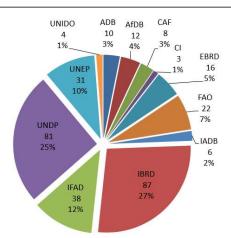
Since inception to March 31, 2020 funding approvals made by the LDCF/SCCF Council totaled USD 358.58 million. Projects represent about 89%, fees for Agencies 9%, and corporate budgets for the Secretariat, the Trustee, STAP and Independent Evaluation Office 2%.

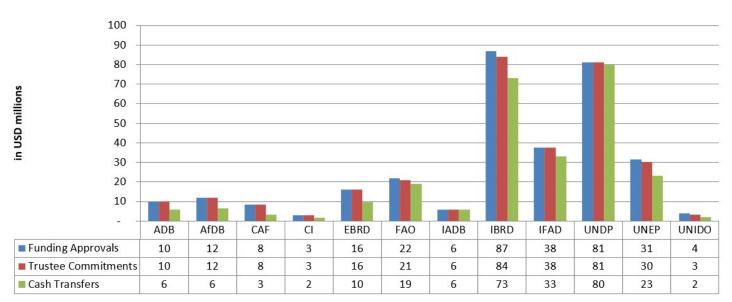


PROJECT FUNDING DECISIONS BY AGENCY

The pie chart shows the project funding decisions by Agency. Of the total USD 318.64 million of approved projects to date, 27% has been allocated to IBRD, 25% to UNDP, 12% to IFAD and 10% to UNEP.

Highlights for the period October 1, 2019 through March 31, 2020:

- Funds Held in Trust represent cumulative cash receipts and investment income less cumulative cash transfers, and amount to USD 73.25 million as of March 31, 2020 (including USD 44.57 million for Program for Adaptation and USD 28.68 million for Program for Technology Transfer). Funds Held in Trust decreased by USD 3.18 million due to cash transfers (USD 4.99 million), offset by cash receipts (USD 0.8 million) and investment income (USD 1.01 million).
- **Funding Decisions Pending Cash Transfer** arising from the LDCF/SCCF Council approvals amount to USD 59.06 million for both Programs.

Funding Availability for Council decision amounts to USD 14.2 million representing a decrease of USD 1.16 million over the prior reporting period because fund transfers exceeded new funding approvals by the Council and CEO, receipt of new funds from donors and investment income earned during the same period.
