### Decision 1/2013      Intersessional Work Program

1. 2. With respect to the following five PIFs approved as part of the work program, the Council requested the Secretariat to arrange for Council Members to receive draft final project documents at least four weeks prior to the CEO's endorsing the project document for final approval by the GEF Agency to provide Council Members the opportunity to transmit to the CEO any concerns they may have:
    - a) **Dominican Republic:** Conserving Biodiversity in Coastal Areas Threatened by Rapid Tourism and Physical Infrastructure Development
    - b) **Egypt:** Grid-Connected Small-Scale Photovoltaic Systems
    - c) **Kenya:** Development of SFM and Support to REDD for Dryland Forests
    - d) **Solomon Islands:** Integrated Forest Management in the Solomon Islands



- e) **EAS Regional (China):** Implementation of the Yellow Sea LME Strategic Action Programme for Adaptive Ecosystem-Based Management under the *EAS Regional: Reducing Pollution and Rebuilding Degraded Marine Resources in the East Asian Seas through Implementation of Intergovernmental Agreements and Catalyzed Investments*
3. With respect to the following three PIFs, the Council requests that the project proposals be deferred for consideration at the June 2013 Council meeting:
- a) **Indonesia:** Promoting Energy Efficiency for Non-HCFC Refrigeration and Air Conditioning (UNDP)
  - b) **Russian Federation:** Save the Source: Catalyzing Market Transformation of Breweries from a Major Natural Resource Consuming Industry to a Pro-active Steward for Resource Efficient Cleaner Production (UNIDO)
  - c) **Russian Federation:** Sustainable Land Management and Ecosystem-based Climate Change Mitigation in the Altai-Sayan Ecoregion (UNDP)
4. With respect to the remaining 47 PIFs and one PDF approved as part of the work program, the Council finds that each of these PIFs/PDF (i) is, or would be, consistent with the Instrument and GEF Policies and procedures, and (ii) may be endorsed by the CEO for final approval by the GEF Agency, provided that the final project documents fully incorporate and address the Council's and the STAP reviewer's [comments on the work program](#), and that the CEO confirms that the project continues to be consistent with the Instrument and GEF policies and procedures.
5. With respect to any PIF approved in this work program, the final project document will be posted on the GEF website for information after CEO endorsement. If the GEF CEO determines that there have been major changes to the project scope and approach since PIF approval, the final project document shall be posted on the web for Council review for four weeks prior to CEO endorsement.
6. Beginning in this work program, the new procedure for tranche fee payment (**Decision 24 / 2012**<sup>1</sup>) will apply to all projects in which 40% of the Agency fees are committed upon approval of this work program and the remaining 60% at CEO endorsement. ## 44<sup>th</sup> Council Meeting – June 2013

### Decision 2/2013      Annual Monitoring Report FY12: Part II

1. The Council, having considered document GEF/C.44/05, [Annual Monitoring Review FY12: Part II](#), welcomed the report and appreciated the reformed AMR process. The Council requested the GEF Secretariat to continue providing two AMR reports per year. The first, presented in the fall, containing a quantitative overview of information on the portfolio under implementation and the second, presented in the spring, containing more in-depth analysis of outcomes, experiences, and lessons learned, including a report on the time elapsed between CEO endorsement/approval and first disbursement.

### Decision 3/2013      First Report of OPS5 and Management Response

1. The Council, having reviewed document GEF/ME/C.44/01, [First Report of the Fifth Overall Performance Study and Management Response](#), requested the Evaluation Office to continue its work to finalize the Fifth Overall Performance Study taking into account comments made in the Council meeting. The Council requested the Secretariat to take the findings of OPS5 into account in preparing draft strategies for GEF-6.

### Decision 4/2013      Update on GEF-5 Programming

1. The Council, having reviewed document GEF/C.44/07, [Update on GEF Programming](#), took note of the approach to future programming presented by the Secretariat for a projected envelope of \$4,066 million for GEF-5.
2. The Council noted its appreciation of all Contributing Participants that have delivered on their pledges in a timely manner and cleared their deferred contributions, thereby mitigating the potential shortfall of resources in GEF-5.
3. The Council urged all Contributing Participants to continue to undertake efforts to deliver on their pledges.
4. The Council agreed to the continuation of the approach it recommended in November 2012, whereby programming would be undertaken for the remainder of GEF-5 maintaining the balance among the original allocations in the GEF-5 replenishment decision, assisting least developed countries (LDCs) and small island developing states (SIDS) in accessing resources, and supporting core obligations to the conventions for which the GEF is a or the financial mechanism.
5. The Council requested the Secretariat to report on the progress in programming at the next Council meeting.

#### **Decision 5/2013      Report on the Pilot Accreditation of GEF Project Agencies**

1. The Council, having reviewed GEF/C.44/09, [Report on the Pilot Accreditation of GEF Project Agencies](#), noted the status of the Stage II reviews conducted by the Accreditation Panel to date. In particular, the Council noted that all Stage II initial desk reviews have been completed, but also that several applicants are undergoing further reviews by the Panel.
2. The Council decided to consider the possibility of a second round of accreditation, including accreditation of bilateral agencies, only once all Stage II reviews are completed.
3. The Council requested the Secretariat to continue to present a progress report on the accreditation pilot at every Council meeting.

#### **Decision 6/2013      Relations with the Conventions and Other International Institutions**

1. The Council, having considered document GEF/C.44/03, [Relations with the Conventions and Other International Institutions](#), welcomed the report and requested the GEF network to continue to work with recipient countries to reflect the guidance and national priorities in their GEF programming and activities.

##### *Update on Mercury Convention Negotiations*

2. The Council, having reviewed document GEF/C.44/04, [Preparing the GEF to serve as the Financial Mechanism of the Minamata Convention on Mercury upon entry into force](#),
3. Welcomed with appreciation the invitation from the Intergovernmental Negotiating Committee to Prepare a Global Legally Binding Instrument on Mercury to the GEF, to be the key element of the Financial Mechanism of the Minamata Convention on Mercury as drafted in Article 13 of the agreed text of the Convention, which will be submitted for adoption and opened for signature in Kumamoto and Minamata, Japan in October 2013.
4. Authorized the use of up to \$10 million for the funding of an early action pre-ratification program for the Minamata Convention to be programed during the remainder of GEF-5, upon request by eligible signatory countries.
5. Requested the GEF Secretariat to develop initial guidelines consistent with the final resolutions of the diplomatic Conference for enabling activities and pre-ratification projects, in consultation with the interim Secretariat of the Minamata Convention, and present this as an information document at the 45th Council Meeting.

## **Decision 7/2013      Note on the Organization of the Fifth GEF Assembly**

1. The Council expressed its appreciation to the Government of Mexico for offering to host the Fifth Assembly meeting and accepted this kind offer. The Assembly will take place in Mexico, on May 28-30, 2014.
2. The Council requested the Secretariat to prepare for the next Council meeting a report on the progress that has been achieved in preparing the Assembly.

## **Decision 8/2013      Work Program**

1. The Council, having reviewed document GEF/C.44/08, [Work Program](#), approved<sup>2</sup> the work program comprising forty eight (48) project concepts and two programmatic approaches, subject to comments made during the Council meeting and additional comments that may be submitted in writing to the Secretariat by July 5, 2013. In addition, six project concepts associated with current and previously approved programmatic approaches are also approved.
2. Total resources approved in this work program amounted to \$369.82 million which include GEF project grants and Agency fees. The work program is comprised of the following Project Identification Forms (PIFs) and Program Framework Documents (PFDs):

With respect to R2R – *Pacific Islands Ridge-to-Reef National Priorities- Integrated Water, Land, Forest, and Coastal Management to Preserve Biodiversity, Ecosystem Services, Store Carbon, Improve Climate Resilience, and Sustain Livelihoods*, the Council requested the Secretariat to arrange for Council members to receive as soon as possible the final Program Framework Document (PFD) that responds to Council comments and to the STAP advice.
  5. With respect to the PIFs approved as part of the work program, the Council finds that each of these PIFs (i) is, or would be, consistent with the Instrument and GEF Policies and procedures, and (ii) may be endorsed by the CEO for final approval by the GEF Agency, provided that the final project documents fully incorporate and address the Council's and the STAP reviewer's comments on the work program, and that the CEO confirms that the project continues to be consistent with the Instrument and GEF policies and procedures.
  6. With respect to any PIF approved in this work program, the final project document will be posted on the GEF website for information after CEO endorsement. If there are major changes to the project scope and approach since PIF approval, the final project document shall be posted on the web for Council review for four weeks prior to CEO endorsement.
  7. The detailed funding decisions taken by the Council during this 44<sup>th</sup> session of the work program is part of the associated [Annex 1](#) appended to this Joint Summary of the Chairs.

**Decision 9/2013      GEF Business Plan and Corporate Budget for FY14**

1. The Council, having reviewed document GEF/C.44/06, [GEF Business Plan and Corporate Budget for FY14](#), took note of the business plan and approved a FY14 corporate budget from the GEF Trust Fund of \$25.426 million, comprised of:
  - (a) \$19.575 million for the GEF Secretariat, which includes:
    - i. \$18.525 million for its core administrative budget;
    - ii. \$0.300 million for a special initiative to support the sixth replenishment negotiations; and

- iii. \$0.750 million for planning of the Fifth GEF Assembly.
- (b) \$2.311 million for the STAP; and
- (c) \$3.540 million for the Trustee, which includes:
  - i. \$3.216 million for its core budget; and
  - ii. \$0.324 million for a special initiative to support the sixth replenishment negotiations.
- 2. The Council requested the Secretariat to propose at its November 2013 meeting a supplemental budget to cover the full costs of the Fifth GEF Assembly.
- 3. The Council also approved a total FY14 administrative budget for the Nagoya Protocol Implementation Fund (NPIF) of \$382,300, comprised of the following allocations from the NPIF to cover the Secretariat's and Trustee's expenses for NPIF administration and implementation:
  - (a) \$342,000 for the GEF Secretariat; and
  - (b) \$40,300 for the Trustee;
- 4. In addition, under agenda item 16, the Council, having reviewed document GEF/ME/C.44/02, [Work Program and Budget of the GEF Evaluation Office](#), had approved a FY14 budget of \$4.180 million for the Evaluation Office, comprising \$3.280 million for its annual budget and \$0.900 million to support multi-annual evaluations.
- 5. The Council requested the Secretariat, in consultation with the GEF entities, to present a combined FY15 corporate budget and business plan covering the FY15-18 period for discussion at its spring 2014 meeting. This combined budget and business plans should report on the use of GEF resources during FY14 and GEF accomplishments over the same period.

**Decision 10/2013      Work Program and Budget of the GEF Evaluation Office**

- 1. The Council, having reviewed document GEF/ME/C.44/02, [Work Program and Budget of the GEF Evaluation Office](#), approved the annual budget for the Evaluation Office for fiscal year 2014 for a total of US\$ 3.28 million. The multi-annual budget for the evaluation program of the GEF Evaluation Office is approved for an amount of US\$ 0.90 million for evaluations carried out in fiscal year 2014 and commitments for evaluations continuing on into fiscal year 2015. The total amount approved for the GEF Evaluation Office is US\$ 4.18 million, which is \$ 1.56 million lower than in fiscal year 2013, when a

peak in funding was caused by OPS5 and the two mid-term evaluations that the Office is undertaking.

2. Given the recent obstacles that the Evaluation Office has faced in accessing ongoing and completed GEF funded projects, the Council notes that several GEF Agencies are now incorporating legal requirements in contractual arrangements that such access should be granted as fully and quickly as feasible, recognizing the independence of the Office and without restrictions. The Council requested the Evaluation Office to interact with the GEF Agencies on this issue and report back to the Council in its next Work Program and Budget whether access has been ensured for all GEF funded projects.
3. The Council requested the Evaluation Office to prepare proposals for the replenishment negotiations for the GEF-6 phase to ensure that the operational nature of its budget is recognized and decided outside the administrative budget of the GEF, to come in line with best international practice. It notes with interest that a peer review will take place of the evaluation function in the GEF in early 2014 and looks forward to receive the findings and recommendations at its June 2014 meeting.

#### **Decision 11/2013      Report of the Selection and Review Committee**

1. The Council, having reviewed GEF/C.44/10, *Report of the Selection and Review Committee*, and taking note of the GEF CEO Self-Assessment for FY13 expressed their high satisfaction with performance and achievements of the GEF CEO during her first 10 months tenure, and agreed to:
  - (i) Confirm the appointment of the GEF CEO and Chairperson for the remainder of her term as per World Bank Group's staff policies, and request the SRC Chair to communicate this decision to the World Bank Human Resources;
  - (ii) Provide the GEF CEO and Chairperson with a 4% salary increase as allocated on confirmation of appointment, and request the SRC Chair to communicate this decision to the World Bank Human Resources.
2. Further, the Council, taking note that the term of the current Director of the Evaluation Office will be expiring on September 11, 2014, and with a view to launch the search process for the new Director agreed to request the SRC to:
  - (i) Present draft terms of reference for the Director of the Evaluation Office for approval by Council at the November 2013 Council meeting;
  - (ii) Develop and present a process for selecting a Director of the Evaluation Office for approval by Council at the November 2013 Council meeting.

## **Decision 12/2013      Other Business**

1. The Council confirmed that it will hold its fall 2013 meeting the week of November 4, 2013.
2. The Council decided to hold its first meeting in 2014 on May 26-27 in Mexico in conjunction with the Fifth GEF Assembly.

The Council finds that each proposal presented to it as part of the work program (i) is or would be consistent with the Instrument and GEF Policies and procedures and (ii) may be endorsed by the CEO for final approval by the Implementing Agency, provided that the draft final project documents fully incorporate and address the [Council's comments on the work program](#), and a confirmation by the CEO that the project continues to be consistent with the Instrument and GEF policies and procedures.

## 45<sup>th</sup> Council Meeting – November 2013

### Decision 14/2013      Annual Monitoring Review FY13: Part I

1. The Council having reviewed GEF/C.45/05, [Annual Monitoring Review \(AMR\) FY 13: Part I](#), welcomes the overall finding that the GEF portfolio under implementation in FY 13 performed satisfactorily across all focal areas. The Council welcomes the project cycle analysis in the management effectiveness section as well as inclusion of an annual status update on Enabling Activities and Programmatic Approaches and the information provided on the National Portfolio Formulation Exercise (NPFE).
2. The Council requests the Secretariat, in collaboration with the Agencies, to report on the progress against GEF-5 programming targets in the Annual Monitoring Review, Part II at the spring 2014 meeting. Subsequent reporting on progress against replenishment programming targets should be included in AMR, Part I.

### Decision 15/2013      Annual Report on Impact and Management Response

1. The Council, having reviewed document GEF/ME/C.45/1, "[Annual Report on Impact](#)", and document GEF/ME/C.45/2, "[Management Response to the Annual Report on Impact](#)," notes the considerable achievements of GEF support to Climate Change Mitigation in China, India, Mexico and Russia. It notes that in several projects progress toward impact was slowed down by barriers to change that were not fully included in project design and implementation. However, it is also noted that the current portfolio of mitigation support has shifted towards tackling broader adoption in a more comprehensive way in mitigation support in GEF-5. The Council requests the Secretariat to include this emphasis and where necessary further strengthen it in the proposals for GEF-6.
2. Furthermore, the Council requests the GEF Secretariat, in collaboration with STAP and other relevant entities, to continue its work on the improvement of the methodology of GHG emission reduction calculations, and to engage in a dialogue to improve (i) the assessment of direct GHG emission reduction during project implementation and at completion, and (ii) improved estimation of indirect GHG emission reduction. The Council requests the GEF Secretariat to report back by the next Council meeting with proposals on the way forward.

**Decision 16/2013      Progress Report of the GEF Evaluation Office Director, including the OPS5 Progress Report and Management Response**

1. The Council, having reviewed document GEF/ME/C.45/03 Rev.01, "[\*Progress Report of the GEF Evaluation Office Director, including the OPS5 Progress Report\*](#)," and GEF/ME/C.45/08, "*Management Response to the Progress Report of the GEF Evaluation Office Director, including the OPS5 Progress Report*," takes note of the on-going work of the Office and the progress report on the Fifth Overall Performance Study of the GEF, as well as the upcoming peer review and the international trends on independence of evaluation. The Council approves the name change of the Office to GEF Independent Evaluation Office (GEFIEO).
2. The Council requests the Secretariat and the Evaluation Office to prepare a proposal for amendment of the Instrument to include the Independent Evaluation Office, to be approved by Council before the Assembly in 2014.

**Decision 17/2013      Mid-Term Evaluation of the System for Transparent Allocation of Resources and Management Response**

1. The Council, having reviewed document GEF/ME/C.45/04, "[\*Mid-Term Evaluation of the System of Transparent Allocation of Resources \(STAR\)\*](#)," and document GEF/ME/C.45/05, "[\*Management Response to the Mid-Term Evaluation of STAR\*](#)," notes the contribution of STAR to increased country ownership and country led programming in the GEF. Without prejudice to the policy recommendations related to the STAR that may emerge from the GEF-6 replenishment negotiations, the Council requests the Secretariat to take into account the following recommendations while preparing the STAR for GEF-6 for Council consideration:
  - (a) Limits for flexible use of focal area allocations for activities could be increased for countries with marginal flexibility;
  - (b) The STAR index could be improved through specification of better indicators and updating of data;
  - (c) The implementation of STAR could be fine-tuned on several aspects, most notably a more thorough calculation of the allocations with sufficient quality control, and improvements in the process for STAR calculation and database management.
2. Given the moderate and relatively slow utilization of Sustainable Forest Management in GEF-5 the Council requests the Secretariat to ensure that the development of new programs should give attention to efforts that would be required to make the GEF partnership aware of the operational rules and procedures of these programs.



**Decision 18/2013      Mid-Term Evaluation of the National Portfolio Formulation Exercise (NPFE) and Management Response**

1. The Council, having reviewed GEF/ME/C.45/06, "[\*Mid-Term Evaluation of the National Portfolio Evaluation Exercise \(NPFE\)\*](#)," and GEF/ME/C.45/07, "[\*Management Response to the Mid-Term Evaluation of the NPFE\*](#)," notes the relevance of the NPFEs to address the pre-identification phase of GEF support and its notable success in creating capacity in countries to coordinate and program GEF interventions. The Council requests the Secretariat to:
  - (a) Include in the final replenishment proposals the continuation of NPFE support in GEF-6, to be implemented through the Secretariat;
  - (b) Use the balance of the GEF-5 NPFE support for programming exercises especially in LDCs and SIDS in 2014, to enable countries on a voluntary basis to prepare for GEF-6;
  - (c) Include in the final replenishment proposals capacity development initiatives for GEF-6 (including NPFE, NDI, NCSA and a follow-up to the Capacity Development Strategy of GEF-5) which aim to achieve a more comprehensive understanding of the GEF in partners and stakeholders at the country level, especially in LDCs and SIDS;
  - (d) Update NPFE guidelines to address information needs of the countries for programming on topics such as eligibility criteria, cofinancing expectations, and funding modalities.

**Decision 19/2013      Progress Report on the GEF Project Cycle Streamlining Measures**

1. The Council, having reviewed document GEF/C.45/04, "[\*Progress Report on the GEF Project Cycle Streamlining Measures\*](#)," acknowledges progress on the implementation of GEF Project Cycle streamlining measures, and the status on the project cycle effectiveness indicators, and notes that further work is required to clarify project cycle time-frame targets and further reduce time elapsed in project preparation.
2. The Council encourages the Secretariat, the GEF Agencies, and recipient countries to work together in order to expedite project preparation.
3. The Council requests the Secretariat, in collaboration with the GEF Agencies, to propose for consideration at the November 2014 Council meeting, a policy for cancellation of projects that exceed time-frame targets for project preparation.
4. The Council agrees to provide the CEO with delegated approval authority for expedited approval of enabling activities requesting grants of up to \$1 million.

5. The Council requests the Secretariat to report at the next Council meeting on progress achieved in: (i) the implementation of the eight streamlining measures, including any possible cost savings; (ii) the harmonization pilot with the World Bank, including possible implications for extending this to other agencies; and (iii) the four inter-agency working groups considering additional streamlining measures.

**Decision 20/2013      Relations with the Conventions and Other International Institutions –  
Statements by the Executive Secretaries of the Conventions**

1. The Council, having considered document GEF/C.45/06, [\*Relations with the Conventions and Other International Institutions\*](#), welcomed the report and requested the GEF network to continue to work with recipient countries to reflect the guidance and national priorities in their GEF programming and activities.

**Decision 21/2013      Amendments to the Instrument**

1. The Council requests the Secretariat to submit a draft decision by January 15, 2014, for consideration and decision by mail, on [\*amendments to the Instrument\*](#) to be recommended to the Fifth Assembly, including but not limited to the Minamata Convention on Mercury.

**Decision 22/2013      Review of GEF Agencies on Environmental and Social Safeguards and Gender Mainstreaming**

1. The Council, having reviewed Council Document GEF/C.45/10, [\*Review of the GEF Agencies on Environmental and Social Safeguards and Gender Mainstreaming\*](#), requests:
  - (a) Each GEF Agency that has not fully met the requirements of the *GEF Policy on Agency Minimum Standards on Environmental and Social Safeguards and the GEF Policy on Gender Mainstreaming* to submit to the GEF Secretariat, by December 15, 2013, a time-bound action plan explaining how it will come into compliance with those provisions not met. The GEF Secretariat will compile these time-bound action plans and forward them to the GEF Council for information by December 31, 2013. The Council agrees to a waiver so that agencies can submit time-bound action plans on gender mainstreaming;
  - (b) Each GEF Agency that has not fully met the requirements of either Policy to report to the Council at its spring 2014 meeting on the progress each has made towards fulfilling its action plans, when the Council may impose specific deadlines on action plans.

2. The Council requests that the GEF Evaluation Office begin its assessment of the *Policy on Agency Minimum Standards on Environmental and Social Safeguards* after the conclusion of the Pilot on Accrediting GEF Project Agencies. The Secretariat will propose a revised Policy for Council consideration taking into account the findings of this evaluation and any guidance from the Council.

**Decision 23/2013      Progress Report on the Pilot Accreditation of GEF Project Agencies**

1. The Council, having reviewed GEF/C.45/12, [Progress Report on the Pilot Accreditation of GEF Project Agencies](#), notes the status of the Stage II reviews conducted by the Accreditation Panel to date. In particular, the Council notes that all Stage II initial desk reviews have been completed as planned and that World Wildlife Fund, Inc. (WWF-US) and Conservation International Foundation (CI) have received approval from the Panel to move from Stage II to Stage III.
2. The Council approves initial grant ceilings for WWF-US and CI, determined in accordance with the provisions set forth in Council document GEF/C.40/09, [Broadening the GEF Partnership under Paragraph 28 of the Instrument](#) (Decision 12 / 2011), as follows:
  - (a) individual project ceiling for a GEF grant: \$65,000,000 for WWF-US and \$120,000,000 for CI; and
  - (b) total project ceiling: \$125,000,000 for WWF-US and \$110,000,000 for CI.
3. The Council authorizes the Secretariat to recalculate these ceilings at the time of project approvals for these agencies and inform the Council of any changes.
4. The Council requests the Secretariat to continue to present a progress report on the accreditation pilot at every Council meeting.

**Decision 24/2013      Note on the Organization of the Fifth GEF Assembly**

1. The Council, having reviewed the [Note on the Organization of the Fifth GEF Assembly](#) (GEF/C.45/07) took note of the proposed preliminary budget and approved an additional \$1,368,528 for the Special Initiative to fund the Organization of the Assembly.

**Decision 25/2013      Work Program**

1. The Council, having reviewed document GEF/C.45/08, [Work Program](#), approves the work program comprising forty one (41) project concepts and one non-expedited enabling activity, subject to comments made during the Council meeting and additional comments that may be submitted in writing to the Secretariat by November 21, 2013. In

addition, Council approves five project concepts associated with a previously approved programmatic approach.

If there are major changes to the project scope and approach after PIF approval, the final project document will be posted on the web for Council review for four weeks prior to CEO considering endorsement.
6. The detailed funding decisions taken by the Council during this 45<sup>th</sup> session of the work program is part of the associated [Annex 1](#) appended to this Joint Summary of the Chairs.

#### **Decision 26/2013      Report of the Selection and Review Committee**

1. The Council notes with regret that Mr. van den Berg's term as Director of the Evaluation Office expires on September 11, 2014. In order to ensure a smooth transition, his successor will need to be appointed by the GEF Council, preferably at its first session in 2014.
2. Having reviewed the [Report of the Selection and Review Committee](#) (Document GEF C.45/09), the Council:
  - (a) Agrees to launch the recruitment process for the Director of the Evaluation Office as soon as possible, based on the attached terms of reference, and in accordance with the recommended "hybrid" process;
  - (b) Takes note of the estimated costs of the recruitment process for the Director of the Evaluation Office, and approves a budget of US\$50,000 for the Special Initiative to complete the recruitment of a new Director of the Evaluation Office;
  - (c) Takes note of the FY14 goals for the EO Director and the GEF CEO and requests the SRC to present the performance evaluation of the EO Director and the GEF CEO for the Council's review at its second meeting in 2014;
  - (d) Agrees with the SRC's positive assessment of the EO Director's FY13 performance and the recommendation to provide the EO Director with a "4" rating on the World Bank's 5-point scale, with an associated merit-based salary increase of 2.5%. The Council requests the SRC to communicate this decision to the World Bank Human Resource Department.
