Decision by Mail – March 2019

Decision 1/2019 GEF-7 Resolution Corrigendum for Council Decision

 The Council, having reviewed document GEF/C.54/19/Rev. 03/Annex.C/Corr.1 (GEF <u>Trust Fund Seventh Replenishment of Resources</u>) regarding the corrigendum to revise the dates in paragraph 8 (b) of GEF-7 Replenishment Resolution, approves the corrigendum as follows:

"The Trustee shall promptly inform all Contributing Participants if a Contributing Participant that has deposited a Qualified Instrument of Commitment and whose contribution represents more than 5 percent of the total amount of the resources to be contributed pursuant to the Seventh Replenishment has not unqualified at least 50 percent of the total amount of its contribution by November 30, 2019, or 30 days after the Effective Date, whichever is later, and at least 75 percent of the total amount of its contribution by November 30, 2020, or 30 days after the Effective Date, whichever is later, and the total amount thereof by November 30, 2021, or 30 days after the Effective Date, whichever is later."

2. The Council further requests the CEO/Chairperson to transmit this decision to the World Bank with a request that the World Bank Executive Directors be invited to adopt the corrigendum to the GEF-7 Replenishment Resolution.

- (d) Agrees with the SRC's recommendation to reappoint Mr. Juha Uitto as Director of the Independent Evaluation Office for a second, and final, five-year term beginning September 2 2019.

- e) Search firm conducts initial screen of all applications received against criteria/qualifications as specified in the ToR for the CEO position;
- f) Search firm presents to SRC a list of all applicants meeting the criteria along with a suggested list of 15-25 applicants who presented the strongest applications;
- g) SRC advises search firm on development of a long list of approximately 10 candidates for further evaluation;
- h) On receipt of evaluations, SRC consults with Council Members on the long list;
- i) Reflecting views received from Council Members, SRC works with the search firm to prepare a final short list of approximately 5 to 6 candidates to be interviewed.
- j) SRC interviews candidates, and consults with Council Members again;
- k) Based on interviews and consultations with Council Members, the SRC makes a recommendation to the Council of three final candidates, in order of preference.
- Council interviews the final three candidates, selects its preferred candidate, and appoints the CEO at the Council meeting prior to the expiration of the term of the incumbent CEO.
- m) New CEO commences in the role upon the expiration of the term of the incumbent CEO.
