Background

The Global Environment Facility (GEF) CSO Network is an independent global alliance of CSOs established to formalize the relationship between CSOs and the GEF based on 6 focal areas i.e. Biodiversity; Climate change; Chemicals and Waste; Land degradation; International waters and Sustainable management of forests.

The Network has evolved over years both organically and externally in terms restructuring and setting normative functioning systems whereas mobilizing resources to play a watch dog role through monitoring of GEF projects and ensuring participation of civil society in GEF decision making and project management.

The 2015 CSO meeting is being organized to share new GEF programming strategy, collate views on CSO engagement with GEF Family.
