# **Background: Transparency**

o Article o 13

#### Paris Agreement Article 13

"In order to build mutual trust and confidence and to promote effective implementation, an <u>enhanced transparency framework</u> for action and support, with built-in flexibility which takes into account Parties' different capacities and builds upon collective experience is hereby <u>established</u>."

# **Background: Transparency**

"The purpose of the framework for transparency of action is to provide a clear understanding of climate change action in the light of the objective towards achieving Parties' individual nationally determined contributions under Article 4, and Parties' adaptation actions under Article 7, including good practices, priorities, needs and gaps, to inform the global stocktake under Article 14."

# **Background: Transparency**

Rationale for the establishment of the CBIT



"Each Party shall regularly provide the following information:

- A <u>national inventory report of anthropogenic emissions</u> by sources and removals by sinks of GHG, prepared using <u>good practice</u> <u>methodologies</u> accepted by the IPCC and agreed upon by the COP serving as the meeting of the Parties to the Paris Agreement.
- Information necessary to <u>track progress made in implementing and</u> achieving its nationally determined contribution under Article 4."

#### Aims of the CBIT

#### Paris Decision Paragraph 85:

- a) To strengthen national institutions for transparencyrelated activities in line with national priorities;
- b) To provide relevant tools, training and assistance for meeting the provisions stipulated in Article 13 of the Agreement;
- c) To assist in the improvement of transparency over time.

#### **GEF's Role in the CBIT**

Paris Decision Paragraph 84: "Decides to establish a CBIT..."

"Urges and requests the GEF to make arrangements to support the establishment and operation of the CBIT as a priority reporting-related need, including through voluntary contributions to support developing country Parties in the sixth replenishment of the GEF and future replenishment cycles, to complement existing support under the GEF."





# Next steps in the establishment of the CBIT

- ✓ Develop CBIT Support Concept
  - Consultations with countries
  - Consultations with other existing/emerging initiatives and UNFCCC
- ✓ Seek GEF Council decision in June 2016
  - Time bound: support until end of GEF-6 (- June 2018)
  - CBIT activities to be mainstreamed into GEF-7 (July 2018 -)
  - Governance
  - WB as Trustee
  - GEF policies and program cycle to apply
- ✓ Solicit voluntary contributions to operationalize CBIT
- ✓ Report to COP 22





# Next steps in the operationalization of the CBIT

- ✓ CBIT architecture deliberated at June 2016 GEF Council
- ✓ Many influencing factors:
  - Voluntary contributions timing and amount
  - Country interests
  - Speed of project preparations
  - Linkage with UNFCCC processes
  - Coordination and existing/emerging initiatives
  - GEF approval process medium size or full size





# Support to be provided by the CBIT

Initial thinking: provide opportunities for all while addressing targeted implementation support

1. National level capacity needs assessment for transparency



- 2. National transparency initiative support
- 3. Global cross-cutting coordinating platform





# **CBIT Programming**

Activity	Indicative allocation
National programs	\$35 million
Capacity needs assessments for transparency	\$10 million total, \$100,000 per country (up to 100 countries)
National transparency initiative support	\$25 million total based on needs assessment prioritization
Regional/global programs and coordination	\$15 million
Total	~\$50 million (TBD)


