1. This half-yearly report summarizes the progress made in programming of GEF-4 resources as of December 31, 2008 and compares cumulative GEF-4 approvals to programming targets for GEF-4. In addition, it details project approvals and endorsements as well as project cancellations during the six-month period from July 1 to December 31, 2008.<sup>1</sup>

### **Cumulative GEF-4 Approvals versus Programming Targets as of December 31, 2008**

2. Between the start of GEF-4 and December 31, 2008, GEF grants and associated Agency fees amounted to \$1,669.47 million, representing over a half of the total resources expected to be available in GEF-4. The distribution of the approved amounts by focal areas/corporate programs compared to the corresponding programming targets are shown in Table 1.<sup>2</sup> The amounts approved for multi-focal projects have been divided and distributed to the contributing focal areas. Similarly, the amounts approved for the Small Grants Program (SGP) have been divided, since SGP core funds are reported under corporate programs and the contributions made by countries, from their Resource Allocation Framework (RAF) allocations for biodiversity or climate change focal areas, are reported under the contributing focal area.

### **Approval of Grants and Agency Fees for the Period July 1 to December 31, 2008**

3. During the six-month period ending December 31, 2008, the GEF approved a total of \$432.12 million for financing projects, consisting of \$378.30 million in project grants, \$16.46 million for project preparation grants, and \$37.36 million in associated fees to Agencies for project cycle management services. A detailed list of approvals are contained in Annexes A,B,C, and D as follows:

- a. The GEF Council approved \$362.49 million in grants for Full Sized Projects and \$34.88 million in associated Agency fees for a total of \$396.37 million (see Annex A);
- b. The CEO, under delegated authority, approved \$25.06 million in grants for Medium Sized Projects and \$2.41 million in associated Agency fees, for a total of \$27.47 million (see Annex B);
- c. The CEO, under delegated authority, approved \$0.71 million for Enabling Activities and \$0.07 million in associated Agency fees, for a total of \$0.78 million (see Annex C); and
- d. The CEO, under delegated authority, approved \$7.50 million for project preparation grants (see Annex D)

### **Cancelled Projects for the Period July 1 to December 31, 2008**

4. Between July 1, 2008 and December 31, 2008, the GEF has cancelled one project, worth \$3.5 million (see Annex E).

### **CEO Endorsement of Projects for the Period July 1 to December 31, 2008**

5. During the six-month period ending December 31, 2008, the CEO endorsed a total of 32 projects accounting for \$193.08 million in grants and \$16.62 million in associated Agency fees,
