1. This bi-annual report summarizes the progress made in programming GEF-4 resources as of December 31, 2009 and compares cumulative GEF-4 approvals to programming targets in GEF-4<sup>1</sup>. In addition, it details project approvals and endorsements as well as project cancellations during the six-month period from July 1 to December 31, 2009.

### **Cumulative GEF-4 Approvals versus Programming Targets as of December 31, 2009**

2. Between the start of GEF-4 and December 31, 2009, GEF grants and associated Agency fees amounted to \$2,447.07 million, representing 86% of programmed resources in GEF-4. The distribution of the approved amounts by focal areas/corporate programs compared to the corresponding programming targets is shown in Table 1. SGP core funds are reported under corporate programs, and contributions made by countries from their Resource Allocation Framework (RAF) allocations for biodiversity or climate change focal areas are reported under the respective focal area.

## Approval of Grants and Agency Fees for the Period from July 1 to December 31, 2009

3. During the six-month period ending December 31, 2009, the GEF approved a total of \$192.32 million for financing projects, consisting of \$175.033 million in project grants, and \$17.29 million in associated fees to Agencies for project cycle management services. Table 2 provides a summary illustration of the distribution according to project types.

4. Between July 1, 2009 and December 31, 2009, the CEO endorsed a total of 54 projects accounting for \$343.69 million in grants and \$31.02 million in associated Agency fees, as detailed in Annex D.

## Project Cancellations for the Period from July 1 to December 31, 2009

5. During the six-month period ending December 31, 2009, the GEF has cancelled 6 projects of a total value of \$23.51 million in grants and \$1.76 million in associated Agency fees, as detailed in Annex E.
