2. Total GEF grants and associated Agency fees approved by Council or the CEO amounted to \$476.50 million, representing 11% of programmed resources. The distribution of the approved amounts as compared to the corresponding programming targets is shown in Table 1 by focal areas, corporate programs and corporate budget.

Approval of Grants and Agency Fees for the Period from January 1 to June 30, 2011

3. During the six-month period ended June 30, 2011, the GEF approved a total of \$285.84 million for financing projects, consisting of \$262 million in project grants, and \$23.83 million in associated fees to Agencies for project cycle management services. Co-financing associated with total approval during this period was \$3,376.92 million (each GEF grant dollar was thus matched by approximately \$12.89 dollars in co-financing). Table 2 provides a summary illustration of the distribution according to project types.

5. Between January 1 and June 30, 2011, the CEO endorsed a total of 69 projects accounting for \$414.73 million in GEF grants and \$33.58 million in associated Agency fees, as detailed in Annex E.

Project Cancellations for the Period from January 1 to June 30, 2011

6. During the six-month ended June 30, 2011, the GEF has cancelled two projects and dropped three others of total value of \$15.64 million in GEF grants and \$1.26 million in associated Agency fees as detailed in Annex F.
