# INTRODUCTION

1. Following the Council decision on *Expediting the Preparation of the Stock of Delayed Projects* (GEF/C.48/04), the GEF Secretariat has continued to report to the Council, through the Annual Monitoring Reports (AMRs), on the status of the stock of delayed projects. In addition to reporting, the Secretariat has also closely monitored the overdue project list and has continuously communicated with the Governments and GEF Partner Agencies to help accelerate the preparation of these projects.

2. This document provides: (a) an update of the GEF Secretariat's monitoring and followup actions; and (b) an analysis of the stock of overdue projects currently subject to the onetime cancellation policy as of May 3, 2016.

# GEF SECRETARIAT'S MONITORING AND FOLLOW-UP ACTIONS

3. The GEF Secretariat has been closely monitoring the overdue project list on a monthly basis. The initial list was included in the annual AMR Part I report, and an updated list is published monthly in the Program Management Bulletin on the GEF website. After the June 2016 Council meeting, the GEF Secretariat will consider to include the list in a Comprehensive Progress Report and circulated to all Agencies for comments and actions before final posting for Council meetings.

4. In compliance with the Council decision on project cancellation, the GEF Secretariat has, since October 2015, sent automated alerts to Governments and Agencies six months prior to the target date for CEO endorsement/approval for all projects, informing them of possible cancellation if projects are not submitted with complete documentation to the GEF Secretariat in due time.

5. More proactively, the GEF Secretariat has communicated with the countries' Operational Focal Points (OFPs) and GEF Partner Agencies about their overdue projects via email or within the context of the national dialogue, expanded constituency workshops, or constituency meetings. In April and May 2016, the Secretariat also sent letters to Ministers of all countries with overdue projects, alerting them about the possible cancellation. While GEF staff maintain continuous communication with the countries' OFPs, the Secretariat has also followed up with Agencies on delayed projects, especially during the monthly Inter-agency meetings.

6. These efforts have resulted in an increased number of overdue projects whose CEO endorsement requests have already been submitted to the GEF Secretariat after the 18-month target since PIF approval by Council, and these projects will not face the one-time cancellation by June 30, 2016. It should also be noted that the very first batch of GEF-6 projects, whose PIFs were approved by the Council in October 2014 and subject to the new cancellation policy, have all been submitted on time.

7. The Secretariat is planning to present to the October 2016 Council meeting an update of the final amount of cancelled funds as of the June 30, 2016 deadline. That report will follow up on the request made by the Council at its October 2015 meeting: "The Secretariat will report back to the Council in June 2016 with a proposal on how to redistribute any resources from cancelled projects that may revert to the Trust Funds, as necessary, to support GEF-6 priorities, taking into account areas of high demand of GEF-6 to date."

### STOCK OF OVERDUE PROJECTS SUBJECT TO THE ONE-TIME CANCELLATION POLICY BY JUNE 30, 2016

# **Overdue Projects with/without Submission**

8. As of May 3, 2016, the amount of funds at risk of cancellation is US\$364 million, representing 66 projects not yet submitted to the Secretariat. It should be noted that only overdue projects without submission to the GEF Secretariat will be subject to the one-time cancellation by June 30, 2016. A further US\$380 million, representing 73 projects, is not subject to cancellation, as those projects have been submitted. Of these, 18 percent exceeded the Secretariat's 10-day service standard for review, while another 8 percent were within the 10-day standard, and a further 27 percent were submitted but returned to the Agency for further revision (Table 1 and Figure 1).

### **Overdue Projects by Number of Months**

### 9. As of May 3, 2016, the overall stock (submitted and non-submitted) of overdue

**projects is** 139 (114 FSPs and 25 MSPs), amounting to a total of US\$744 million. Table 2 below categorizes this stock of overdue projects by number and grant amount, according to the number of months since PIF approval. Forty percent of the total number of overdue projects (56 FSPs) were less than 36 months but more than 24 months under preparation, representing US\$368 million by grant amount, or 49 percent of the total in overdue grant funds.


### **Changes in the Stock of Overdue Projects**


10. The amount of funds at risk of cancellation has fallen slightly since the last GEF Council meeting in October 2015, from US\$378 million to US\$364 million, while the number of projects has slightly increased from 63 to 66. At the same time, the number of overdue projects that were already submitted to the GEF has increased from 50 to 73 projects, with total grants rising from US\$235 million to US\$380 million (Table 3 and Figure 2).







11. Overall, the stock of overdue projects<sup>1</sup> has still increased since the 2015 AMR Part I, as shown in Table 4 and Figure 3. As of September 8, 2015 (the date used for the analysis presented to the October 2015 Council), there were 97 overdue FSPs (representing US\$588 million in grant amount) and 16 overdue MSPs (representing US\$25 million in grant amount). As of May 3, 2016, the stock included 114 FSPs amounting to US\$710 million, and 25 MSPs amounting to US\$34 million in grant amount. Over the eight month period, the stock of delayed projects increased because 69 new projects became overdue while 43 projects were approved or endorsed.
