# JOINT SUMMARY OF THE CHAIRS 55<sup>TH</sup> GEF COUNCIL MEETING DECEMBER 18 – 20, 2018

#### **OPENING OF THE MEETING**

1. The meeting was opened by Naoko Ishii, Chief Executive Officer/Chairperson of the Facility.

#### **ELECTION OF A CHAIRPERSON**

2. The Council elected Mr. Abdul Bakarr Salim of Sierra Leone, the Council member representing the Coastal West Africa Constituency, composed by Benin, Cote d'Ivoire, Ghana, Guinea, Liberia, Nigeria, Sierra Leone, and Togo.

#### ADOPTION OF THE AGENDA

3. The Council adopted the provisional agenda set forth in document GEF/C.55/01.

REPORT OF THE CHAIRPERSON OF THE SCIENTIFIC AND TECHNICAL ADVISORY PANEL

4. Ms. Rosina Bierbaum, the Chairperson of the Scientific and Technical Advisory Panel, made a statement to the Council on the activities undertaken by the Panel.

RELATIONS WITH THE CONVENTIONS AND OTHER INTERNATIONAL INSTITUTIONS

5. Rossana Silva-Repetto, Executive Secretary of the Minamata Convention, made a presentation about the outcomes of the Second Conference of the Parties to the Minamata Convention.

#### **DECISIONS APPROVED**

6. The Council approves the following decisions with respect to its agenda items.

Decision on Agenda Item 04. Policy Measures to Enhance Operational Efficiency, Accountability and Transparency

- 7. The Council, having reviewed document GEF/C.55/04/Rev.01, Policy Measures to Enhance Operational Efficiency, Accountability and Transparency, approves the following:
  - (a) An amendment to the Cancellation Policy (OP/PL/02, Council document GEF/C.48/04), as set out in Annex I;
  - (b) An amendment to the Project and Program Cycle Policy (OP/PL/01, Council document GEF/C.50/08/Rev.01), as set out in Annex II; and
  - (c) A one-time cancellation, with immediate effect, of any GEF funds approved for Programs on or before June 30, 2014 that (i) have not been committed towards the Program's Child Projects, or (ii) have not been spent by the Program's Child Projects and have been returned to the Program set-aside.

Decision on Agenda Item 05. Policy on Access to Information

8. The Council, having reviewed document GEF/C.55/06, Policy on Access to Information, approves the Policy contained in Annex I to the document.

Decision on Agenda Item 06. Updated Policy on Environmental and Social Safeguards

- 9. The Council, having reviewed document GEF/C.55/07/Rev.01, Updated Policy on Environmental and Social Safeguards, approves the Policy contained in Annex I to the document, which supersedes the 2011 Policy on Agency Minimum Environmental and Social Safeguard Standards (Council document GEF/C.41/10/Rev.01).
- 10. Further, the Council requests the Secretariat to propose a procedure to inform the Council of possible non-compliance with the minimum standards contained in the Policy, where reputational risks for the GEF may arise, for the Council's consideration at its 56th meeting in the Spring of 2019.

Decision on Agenda Item 07. Harmonizing the Rules and Requirements for all Agencies

- 11. The Council, having reviewed document GEF/C.55/08, Harmonizing the Rules and Requirements for all Agencies, takes note of the latest information on the GEF's share of each Agency's portfolio.
- 12. The Council requests Agencies to report to the Secretariat the volume of their non-GEF portfolios on an annual basis, starting on June 30, 2020, and the Secretariat to compile and present such reports for Council review and decision starting in the Fall of 2020.

- 13. The Council further requests the Secretariat to monitor the application of a 30% ceiling on the GEF's share of Agencies' portfolios, and report on progress and lessons learned at the 61st Council meeting in the Fall of 2021.
- 14. In addition, the Council requests that the Secretariat, in collaboration with a Working Group of interested Council members, consider questions around the concentration of GEF resources across Agencies, and develop further the modalities for the implementation of a 30% ceiling, and make recommendations for Council consideration at its 56th meeting in the Spring of 2019.

Decision on Agenda Item 08. Updating the GEF's Minimum Fiduciary Standards Related to Anti-Money Laundering and Combating the Financing of Terrorism

- 15. The Council, having reviewed document GEF/C.55/09, Updating the Minimum Fiduciary Standards on Issues Related to Anti-Money Laundering and Combating the Financing of Terrorism, approves, with immediate effect, the minimum requirements for Agencies on anti-money laundering and combating the financing of terrorism contained in Annex I of this document and requests the Secretariat to include those minimum requirements in an updated version of the Minimum Fiduciary Standards for GEF Partner Agencies (GA/PL/02).
- 16. The Council requests Agencies to certify that they meet the approved minimum requirements, or present a time-bound action plan to achieve compliance, no later than April 30, 2019. The Council requests the Secretariat to compile Agencies' certifications and any action plans for the Council's review and decision at its 56<sup>th</sup> meeting in the Spring of 2019.

Decision on Agenda Item 09. GEF-7 Non-Grant Instrument Program

17. The Council, having reviewed document GEF/C.55/12, GEF-7 Non-Grant Instrument Program, takes note of the implementation framework for the NGI Program. The Council also requests the Secretariat and the Trustee to provide an updated report on non-grant instrument reflows at the Fall 2019 Council meeting.

Decision on Agenda Item 11. Semi-Annual Evaluation Report June 2018

18. Regarding the Semi-Annual Evaluation Report of the Independent Evaluation Office. The Council, having reviewed the "Semi-Annual Evaluation Report of the GEF Independent Evaluation Office: November 2018," endorses the recommendations of the evaluations included. The Council endorses the proposal for the peer review of the Independent Evaluation Office.

Decision on Agenda Item 12. Work Program

19. The Council, having reviewed document GEF/C.55/10, Work Program for GEF Trust Fund, approves the Work Program comprising 18 projects, subject to comments made during

the Council meeting and additional comments that may be submitted in writing to the Secretariat by January 7, 2018.

20. Total resources approved in this Work Program amounted to \$157.8 million which include GEF project financing and Agency fees. The Work Program is comprised of the following Project Identification Forms (PIFs):

- 21. With respect to the PIFs approved as part of the Work Program, the Council finds that each of these PIFs (i) is, or would be, consistent with the Instrument and GEF policies and procedures, and (ii) may be endorsed by the CEO for final approval by the GEF Agency, provided that the final project documents fully incorporate and address the Council's and the STAP reviewer's comments on the Work Program, and that the CEO confirms that the project continues to be consistent with the Instrument and GEF policies and procedures.
- 22. With respect to any PIF approved in this Work Program, the final project document will be posted on the GEF website for information after CEO endorsement. If there are major changes to the project objectives or scope since PIF approval, the final project document shall be posted on the web for Council review for four weeks prior to CEO endorsement be circulated for Council review for four weeks prior to CEO endorsement/approval.
- 23. The Detailed funding decisions taken by the Council during this 55th session of the work program is part of the associated Annex 1 appended to this Joint Summary of the Chairs.

Decision on Agenda Item 13. Annual Portfolio Monitoring Report 2018

24. The Council, having reviewed document GEF/C.55/03, Annual Portfolio Monitoring Report 2018, welcomes the overall finding that the GEF portfolio under implementation in FY18 performed satisfactorily across all focal areas.

Decision on Agenda Item 14. Relations with the Conventions and Other International Institutions

25. The Council, having considered document GEF/C.55/11, Relations with the Conventions and Other International Institutions, welcomed the report and requested the GEF network to continue to work with recipient countries to reflect the guidance and national priorities in their GEF programming and activities.

Decision on Agenda Item 15. Options for a Responsible Investment Strategy

26. The Council reviewed the document GEF/C.55/13, Responsible Investment for the GEF Trust Fund as part of the World Bank Trust Fund Pool, in response to the GEF-7 Policy Recommendation to develop Responsible Investment options for GEF Trust Fund, and acknowledges the progress made by the World Bank as Trustee of the GEF Trust Fund in developing Responsible Investment Guiding Principles and takes note of the World Bank's proposal to identify Environmental, Social, and Governance Integration as the overarching approach for the GEF Trust Fund as part of the World Bank Trust Fund Pool, subject to approval within the World Bank's governance structures. The Council further requests the Trustee to present a proposal for an ESG Investment Strategy for the GEF Trust Fund to the Council for consideration, promptly following the approval of the overarching Responsible Investment Guiding Principles by the World Bank.

- 27. The Council, having considered the oral Report from the Ad-hoc Working Group on Governance, approves the updated membership of the Working Group on Governance as follows:
  - (a) Mathew Haarsager, United States Council member, to replace Geoffrey Okamoto.
  - (b) Adriana Flachier Alternate Council Member of the Constituency of Brazil, Colombia and Ecuador to replace Camila Zepeda Lizama, former Council Member of Costa Rica, El Salvador, Guatemala, Honduras, México, Nicaragua, Panamá and Venezuela.

Decision on Agenda Item 17. Strengthening Consultations with Civil Society: Proposed
Topic for Discussion at the Consultations of the 55th GEF
Council Meeting

- 28. The GEF Council, having considered Document GEF/C.55/05, Strengthening Consultations with Civil Society: Proposed Topic for Discussion at the 56th GEF Council Meeting, selects the following topics to be addressed as part of the future Consultations as follows:
  - (a) At the 56<sup>th</sup> Council Meeting in June 2019: Plastics management to avoid pollution: experiences by Civil Society and Community-Based Organizations;
  - (b) At the 57<sup>th</sup> Council Meeting in December 2019: Illegal Wildlife Trade: A Civil Society Perspective.

Decision on Agenda Item 18. Report of the Selection and Review Committee

- 29. The Council, having reviewed document GEF/C.55/14, *Report of the Selection and Review Committee (SRC)*:
  - (a) Takes note of the FY19 goals for the Director of the Independent Evaluation Office (IEO) and the GEF CEO and requests the SRC to present the performance evaluation of the IEO Director and the GEF CEO for the Council's review at its 56th meeting.
- 30. In addition, and subject to a 'no objection' period ending on Thursday 24 January 2019 at 1800hrs EST (US), the Council<sup>7</sup>:
  - (b) Agrees with the SRC's assessment of the GEF CEO's FY18 performance and the recommendation to provide the GEF CEO with a "4" rating on the World Bank's 6-point scale and taking into account the GEF CEO's current salary zone

placement, in accordance with the World Bank's Merit Increase Matrix, the SRC recommends a merit-based salary increase in FY18 for the GEF CEO that is consistent with World Bank's Merit Increase Matrix. The Council requests the SRC to communicate this decision to the World Bank Human Resource Department.

- (c) Agrees with the SRC's assessment of the GEF IEO Director's FY18 performance and the recommendation to provide the GEF IEO Director with a "4" rating on the World Bank's 6-point scale, and taking into account the IEO Director's current salary zone placement, in accordance with the World Bank's Merit Increase Matrix, the SRC recommends a merit-based salary increase in FY18 for the IEO Director that is consistent with World Bank's Merit Increase Matrix. The Council requests the SRC to communicate this decision to the World Bank Human Resource Department.
- (d) Agrees with the SRC's recommendation to reappoint Mr. Juha Uitto as Director of the Independent Evaluation Office for a second, and final, five-year term beginning September 2 2019.

Decision on Agenda Item 19. Other Business

31. The Council decides that it will hold its Spring 2020 meeting during the week of June 1, 2020, and the Fall 2020 meeting during the week of December 7, 2020.
