World Bank/GEF Sustainable Land Management II Project (SLMP2)

The Government of Ethiopia, the GEF and the World Bank are extremely proud to be able to offer the opportunity for replenishment participants to visit the award-winning land degradation projects in the Tigray region.

What to expect

The proposed field trip will visit Ethiopia's Tigray region which, supported by the World Bank/GEF Sustainable Land Management II Project (SLMP2), has achieved impressive progress in fighting land degradation under extremely challenging conditions in the past few years.

The project focuses on watershed rehabilitation through a multi-sectoral landscape approach, helping restore degraded lands and ecosystem services to benefit smallholder farmers.



Tigray recently won the World Future Council's (WFC) 2017 Gold Award for best policies to combat desertification and land degradation. In their announcement, the WFC noted that "*the people of Tigray are restoring land on a massive scale.....erosion has decreased significantly, groundwater levels are recharged, and the uptake of sustainable agricultural practices made a significant contribution to food self-sufficiency and economic growth.*"

The project

The Sustainable Land Management II Project financed by the GEF (US\$ 13.0 million) and implemented by the World Bank and the Ministry of Agriculture was designed to reduce land degradation and improve land productivity in 135 watersheds in Ethiopia. It began implementation in November 2013. The project's objectives were pursued by providing capital investments, technical assistance and capacity building to smallholder farmers in the targeted watersheds, and to national and sub-national government institutions. The project covers 937 villages in the National Regional States of Amhara, Tigray, Oromiya, the Southern Nations, Nationalities, and Peoples' Region (SNNP), Gambela, and Benshangul Gumuz. The project emphasizes a multi-

sectoral landscape approach, supporting government in coordinating efforts on land use, land management, and land administration. It has helped to not only improve agricultural productivity, but also build resilience to floods and droughts, foster reforestation, food and water security, ultimately helping reduce poverty.
