AGENDA ITEM 1. ELECTION OF THE CHAIR

- 2. In accordance with paragraph 12 of the *Rules of Procedure for the GEF Assembly*, the Assembly is to elect a Chair from among the Representatives attending the meeting. The Chair and Vice-Chairs of the Assembly are to constitute the Bureau of the meeting. The CEO is to serve as an ex-officio member of the Bureau, in accordance with paragraph 15 of the *Rules of Procedure for the GEF Assembly*.
- 3. The Assembly is invited to elect its Chair.

AGENDA ITEM 2. ELECTION OF THE VICE-CHAIRS

- 4. In accordance with paragraph 12 of the *Rules of Procedure for the GEF Assembly*, the Assembly is to elect two Vice-Chairs from among the Representatives attending the meeting. One Vice-Chair is to be a Representative of a recipient country Participant, and one Vice-Chair is to be a Representative of a non-recipient country Participant.
- 5. The Assembly is invited to elect its two Vice-Chairs.

AGENDA ITEM 3. ADOPTION OF THE AGENDA AND ORGANIZATION OF WORK

- 6. A provisional agenda for consideration by the Assembly has been circulated to all Participants as document GEF/A.6/01.
- 7. In addition to plenary meetings, which will be held on both days of the Assembly, 14 key issues are to be discussed at high-level round tables for ministers and other heads of delegation. A summary is to be presented to the plenary.
- 8. A provisional timetable for the Assembly is annexed to this document.
- 9. The Assembly is invited to adopt the agenda for its sixth meeting.

AGENDA ITEM 4. WELCOMING ADDRESSES BY THE CEO OF THE FACILITY AND BY THE PRIME MINISTER OF VIET NAM

10. The opening session of the Sixth GEF Assembly has been organized in collaboration with the host government. It includes a statement by the CEO of the GEF and a statement by the Prime Minister of Viet Nam.

AGENDA ITEM 5. PLENARY DISCUSSION

11. Three sessions will be part of plenary discussions.



- (a) Message from Science: The ecosystems, biomes and processes that regulate the stability and resilience of the Earth system are being stretched to a breaking point.
- (b) Delivering Transformation, Business as usual will guarantee disaster. To change the course of the planet, incremental change will not suffice: the challenge is just too great for that. The only solution is transformational, systems change.
- (c) GEF-7 and Systems Change: With its unique mandate across multiple multilateral environmental agreements and its financing, holistic approach, increasing engagement with the private sector and wide network of partners the GEF is particularly well placed to help catalyze the required transformation.

AGENDA ITEM 6. HIGH-LEVEL ROUND TABLES WITH PARTICIPATION BY MINISTERS AND OTHER HEADS OF DELEGATION

- 12. A document about the GEF Assembly Round Tables, *Round Table Discussions*, is submitted to the Assembly as document GEF/A.6/Inf.02.
- 13. Round table discussions will be key features of the GEF Assembly in Da Nang, Vietnam. The sessions will debate how GEF and countries could better address challenges to the global environment. Simultaneous interpretation will be available in English, French and Spanish.
- 14. Round tables will be composed of speakers from different sectors including government, international organizations, and private sector. Attendance will be open to Assembly invitees, whom will be encouraged to participate with questions and comments.
- 15. The round tables have been structured to provide for a moderated, interactive and free-flowing dialogue among the participants.
