## STATUS OF COMMITMENTS AND PLEDGES TO THE GEF TRUST FUND

The attached tables present the status of commitments and pledges to the First Replenishment of the GEF. At the last GEF Council meeting in March 1996, total pledges to this replenishment totaled SDR 1,445.14 million. Since that last meeting, Luxembourg notified the GEF that it would contribute SDR 4 million, thus bringing total pledges to SDR 1,449.14 million.

Table 1 summarizes the commitments and pledges made to the First Replenishment. It shows the composition of those commitments received thus far from Contributing Participants, as well as the total amount outstanding. As last reported, total commitments received thus far totaled SDR 1,331.16 million and pledges outstanding were SDR 107.5 million. Subsequently, the GEF received formal notifications of participation from Ireland, Italy, and Mexico for SDR 1.71 million, SDR 81.86 million, and SDR 4 million respectively, as well as the pledge from Luxembourg for SDR 4 million. As a result, commitments received increased to SDR 1418.73 million and outstanding pledges decreased to SDR 23.93 million (includes the pledge from Luxembourg).

Table 2 lists the pledges to the First Replenishment for which Instruments of Commitment have not yet been received. These outstanding pledges are from Argentina, Brazil, Luxembourg, and Spain.
