Mr. Chairperson, Excellencies, and Distinguished Ladies and Gentlemen, I bring greetings from Malawi, The Warm Heart of Africa.

Mr. Chairperson, Malawi would like to join those that have spoken already in congratulating the Chief Executive Officer and Chairperson of the Global Environment Facility, the World Bank, as the GEF Trustee, and all Participants to the Seventh Replenishment of the GEF Trust Fund for the commendable work done during the Seventh GEF (GEF-7) Replenishment Cycle.

GEF-7 comes at a very critical point in time where global ecosystems continue to be degraded; hard earned development gains continue to be destroyed by floods; communities continue to be food insecure; with these trends set to increase in the future unless a major transformation of key economic systems to reduce the global environmental footprint is achieved.

I would like to thank the Donors that have supported a strong and effective GEF-7 replenishment and for raising USD 4.1 Billion amidst them facing their own challenging national circumstances. And to all 183 member countries and GEF Agencies for the collaboration that is demonstrated through these partnerships. Malawi is proud to be part of this partnership, which is humanity's boldest effort to protect the global commons.
