STATUS OF PLEDGES AND COMMITMENTS TO THE GLOBAL ENVIRONMENT FACILITY TRUST FUND

1. First Replenishment of the GEF (GEF-1)

Table 1 presents the status of pledges and commitments for GEF-1 as of September 30, 1999. Total pledges are SDR 1,449.14 million (US\$ 1,998.90 million at September 30, 1999 exchange rates).

<u>Commitments</u>: There have been no new commitments since the May 1999 Council meeting. As of September 30, 1999, total commitments received from Contributing Participants are SDR 1,445.14 million (US\$ 1,993.38 million).

Outstanding commitments: The commitment from Brazil for SDR 4.00 million (US\$ 5.52 million) has not yet been received.

Arrears and Deferred Contributions: On June 10, 1999, the US paid US\$67.5 million, which triggered the release of US\$ 21.05 million equivalent of contributions previously deferred. In addition, in August, Italy paid ITL 119,852 million (US\$ 61.90 million, clearing its arrears in full), Egypt paid EGP 1.7 million (US\$ 0.50 million), and Argetina paid \$0.25 million. Table 2 shows the status of arrears and deferred contributions by country.

2. Second Replenishment of the GEF (GEF-2)

Table 3 presents the status of pledges and commitments for GEF-2 as of September 30, 1999. Total pledges are SDR 1,452.84 million (US\$ 2,004 million at September 30, 1999 exchange rates).

<u>Commitments</u>: The Advance Contribution Scheme of GEF-2 became effective on October 16, 1998. To date, Instruments of Commitment totaling SDR 891.99 million (US\$ 1,230.38 million) have been deposited by 26 countries. These countries are Australia, Austria, Belgium, Canada, China, Côte d'Ivoire, Czech Republic, Denmark, Finland, Germany, Greece, India, Ireland, Japan, Korea, Luxembourg, Mexico, The Netherlands, New Zealand, Nigeria, Norway, Portugal, Slovenia, Switzerland, Turkey, and the United Kingdom.

<u>Outstanding commitments</u>: As of September 30, 1999, pledges for which commitments have not yet been received total SDR 560.86 million (US\$ 773.63 million) from 10 countries.

<u>Status of replenishment effectiveness</u>: An additional SDR 268.01 million (US\$ 369.69 million) in commitments must be submitted to the Trustee for GEF-2 to become effective.
