PROGRESS REPORT ON THE LEAST DEVELOPED COUNTRIES FUND AND THE SPECIAL CLIMATE CHANGE FUND

# **Recommended Council Decision**

The LDCF/SCCF Council, having considered document GEF/LDCF.SCCF.34/05 *Progress Report on the Least Developed Countries Fund and the Special Climate Change Fund*, welcomes the report and takes note with appreciation the progress made under the LDCF and the SCCF.

#### **EXECUTIVE SUMMARY**

- 1. This report provides an update on the progress made in the operations of the Least Developed Countries Fund (LDCF) and the Special Climate Change Fund (SCCF) during the reporting period between October 1, 2022 and March 31, 2023. The financial status updates provided by the Trustee of the LDCF and SCCF are as of March 31, 2023.
- 2. As of March 31, 2023, total cumulative pledges and signed contribution agreements to the LDCF amounted to \$2,065.41 million from 28 donors. Of this amount, \$1,875.44 million, or approximately 90.80 percent, had been received.¹ Cumulative LDCF funding decisions by the LDCF/SCCF Council and the CEO amounted to \$1,762.66 million. Resources available for new funding decisions amounted to \$211.87 million.²
- 3. During this reporting period, a total of \$93.95 million in new pledges were made from Belgium, Germany, Netherlands, Slovenia, Sweden, and Switzerland.
- 4. Since inception, the LDCF has approved 386 projects. During this reporting period, two LDCF Full-Sized Projects (FSPs) were approved at the 33<sup>rd</sup> LDCF/SCCF Council as part of the December 2022 Work Program. Nineteen LDCF projects were CEO endorsed for implementation. Annex I provides a full list of approved LDCF projects and programs to date.
- 5. Six projects requesting \$63.49 million in total, of which \$60.13 million is from the LDCF and \$3.36 million from the SCCF,<sup>3</sup> inclusive of GEF project financing and Agency fees, are being presented to the 34<sup>th</sup> LDCF/SCCF Council in June 2023 for approval.<sup>4</sup> This is the second Work Program of the GEF-8 Period. The LDCF/SCCF Work Program constitution follows the operational improvements agreed by the 32<sup>nd</sup> LDCF/SCCF Council in June 2022, as stipulated in the GEF Programming Strategy on Adaptation to Climate Change for the Least Developed Countries Fund and Special Climate Change Fund for the GEF-8 period of July 2, 2022 to June 30, 2026 and operational improvements.<sup>5</sup>
- 6. As of March 31, 2023, 51 least developed countries (LDCs) accessed approximately \$12.20 million in support of the preparation of national adaptation programs of action (NAPAs).

Additionally, LDCF support for formulation of national adaptation plan (NAP) processes totaled \$60.33 million as of March 31, 2023.

- 7. Since GEF-7, the LDCF has focused on the NAP implementation, as countries are eligible to receive support from the Green Climate Fund (GCF) for NAP formulation.
- 8. The LDCF portfolio aims to reduce the vulnerability of an estimated 60.17 million people and better manage 9.62 million hectares of land to withstand the effects of climate change. Further, 2.11 million people will be trained to identify, prioritize, implement, monitor and/or evaluate adaptation strategies and measures. Additionally, LDCF projects are expected to develop or strengthen 3,164 policies, plans and frameworks to identify, prioritize, and integrate adaptation strategies and measures.
- 9. As for the SCCF, cumulative pledges amounted to \$396.17 million as of March 31, 2023. Of the total resources pledged, \$362.82 million or approximately 91.6 percent had been received. Cumulative SCCF funding decisions by the Council and the CEO amounted to \$365.14 million.<sup>6</sup> Funds available to support Council or CEO decision were \$23.89 million as of March 31, 2023. \$39.23 million in new pledges were received for the SCCF during this reporting period, from Canada, Denmark, Germany, Ireland, Slovenia, Switzerland, and the United Kingdom.
- 10. Since its inception, the SCCF has approved support for 94 projects, including 21 Multi Trust Fund Projects (MTFs). During the reporting period, one new FSP had its PIF approved, and two MSPs were CEO approved though the two-step approach. These three projects have a total value of \$1.41 million in SCCF finance. All these three projects are MTFs with the LDCF supported through the Challenge Program for Adaptation Innovation.
- 11. New funding commitments and contributions made during this reporting period for SCCF window A focused on the climate change adaptation priorities of Small Island Development States. However, the SCCF's window B focused on technology transfer, innovation, and provide sector engagement, is still under-resourced despite its demonstrated strong potential for impact and engagement of non-traditional partners in the GEF.
- 12. The SCCF portfolio aims to reduce the vulnerability of an estimated 8.91 million people and better manage 5.16 million hectares of land to withstand the effects of climate change. Further, 218,865 people will be trained to identify, prioritize, implement, monitor and/or evaluate adaptation strategies and measures. Additionally, SCCF projects are expected to develop or strengthen 486 policies, plans and frameworks to identify, prioritize, and integrate adaptation strategies and measures.
- 13. Progress made by the Challenge Program for Adaptation Innovation continues to demonstrate its potential to effectively address unmet needs for climate change adaptation

innovation. This program has successfully forged partnerships with a growing set of climate adaptation innovation leaders, particularly in the private sector, which the GEF has not been able to engage through more traditional programming modalities. A total of 19 projects have been approved through two initial rounds of this challenge program. At the end of this reporting period, 14 of the 19 winning projects concepts were CEO approved. At the time of publication of this report, an additional four projects had been CEO approved, and one was under preparation for final CEO approval for LDCF and SCCF support in partnership with GEF Agencies.

#### Introduction

1. This report provides an update on progress made in the operations of the Least Developed Countries Fund (LDCF) and the Special Climate Change Fund (SCCF) since the inception of the two funds, as well as specific activities during the reporting period of October 1, 2022, to March 31, 2023. Table 1 below presents a summary of LDCF and SCCF operations, including total cumulative pledges, paid contributions, and project approvals. Dollar figures in this table are based on information from the current Trustee Status Reports for the LDCF and SCCF.

- 2. Table 2 presents a numerical summary of progress made in Fiscal Year 2023, from July 1, 2022 to June 30, 2023.
- 3. During the 32<sup>nd</sup> meeting of the LDCF/SCCF Council on June 23, 2022, the Council approved the GEF Programming Strategy on Adaptation to Climate Change for the LDCF and SCCF for the GEF-8 Period of July 1, 2022 to June 30, 2026 and Operational Improvements. The strategy was fully informed by the latest scientific findings, including reports from Intergovernmental Panel on Climate Change (IPCC), the Independent Evaluation Office's 2020

Program Evaluation of the LDCF<sup>14</sup> and the 2021 Program Evaluation of the SCCF<sup>15</sup>. It is also responsive to the guidance received from the Conference of the Parties (COP) to the United Nations Framework Convention on Climate Change (UNFCCC) and the Paris Agreement.

- 4. The GEF Secretariat also continued actively engaging throughout this reporting period on the roll out of the GEF-8 Programming Strategy on Adaptation to Climate change with relevant stakeholders, particularly LDCs and Small Island Developing States (SIDS). For example, at COP 27, in November 2022, the GEF Secretariat hosted and engaged in a set of events on the rollout of the GEF-8 strategy, and had several meetings with countries, GEF Agencies and a diverse set of project executing partners to support programming innovative and impactful programming in the 2022-26 period. The GEF Secretariat briefed the delegates on the new strategy, including key thematic and priority areas, as well as the financial scenarios. Interaction at this set of events has provided opportunities for engagement of the GEF Secretariat with LDCs, and SIDs, and laid groundwork for country-owned programming and implementation of the GEF-8 strategy.
- 5. During the Fifth United Nations Conference on the Least Developed Countries (LDC5), the GEF Secretariat organized a high-level panel discussion side event titled *Least Developed Countries Fund: Catalyzing climate adaptation actions in Least Developed Countries*. The event, which took place on March 6, 2023, aimed to build political momentum and enhance financing

for the LDCF to catalyze climate adaptation action in the LDCs in line with the GEF-8 Climate Change Adaptation Strategy. The event was opened by the GEF CEO and Chairperson, and the Honourable Prime Minister of the Royal Government of Bhutan provided opening remarks. Ministers and high-level representative from Belgium, Malawi, Nepal, Tuvalu, and United States participated in the discussion. The Executive Secretary of UNFCCC provided closing remarks. The high-level participants from both LDC and donors shared their insights on how the GEF is catalyzing adaptation action with concrete positive impacts for their economies, environment, and people in their countries. The delegates highlighted the need to strengthen adaptive capacity and resilience to climate change for sustainable development as well as the involvement of the private sector to build upon the LDCF investments.<sup>21</sup>

6. During this reporting period, progress was made in the planning and implementation of the GEF-8 Dedicated Programs. For example, the Secretariat convened a Sub-regional Workshop from March 23-24, 2023, on Climate Change Adaptation for four countries in Southern Africa (Angola, Lesotho, Malawi, Mozambique, and Zambia) This workshop was the first in a series of similar workshops to be conducted as part of the GEF-8 Strategy implementation of the Dedicated Program *Outreach and Capacity Support for LDC and SIDS Planning and Programming* called for in the GEF-8 Strategy. A major workshop was held shortly after this reporting period, in collaboration with the LDC Chair, on April 24 to 28, 2023 in Dakar, Senegal, for 17 French-speaking African countries and Haiti. Additional workshops in other sub regions are planned in the coming months. More information is provided on the Dedicated Programs in paragraphs 57 to 72 of this report.

### **LEAST DEVELOPED COUNTRIES FUND**


### Pledges and Contributions to the LDCF

- 7. As of March 31, 2023, cumulative pledges to the LDCF amounted to \$2,065.41 million. Of the resources pledged, \$1,875.44 million or about 90.80 percent had been received.
- 8. Also as of March 31, 2023, LDCF resources available for funding decisions amounted to \$211.87 million.
- 9. A total of \$93.94 million in new pledges were made to the LDCF between October 1, 2022 and March 31, 2023. Paid contributions received during this reporting period totaled \$107.69 million from Denmark, France, Germany, Netherlands, Slovenia, Sweden, and Switzerland during this period. Annex IV presents detailed Trustee information. Figure 1 shows total annual and cumulative LDCF contributions finalized for each completed fiscal year.<sup>22</sup>

# **Progress in LDCF Operations**

- 10. LDCF programming in GEF-8 is building on the very strong track record of access by all 47 LDCs during the GEF-7 period, from July 1, 2018 to June 30, 2022.
- 11. During the reporting period, two projects were approved by the LDCF/SCCF Council as part of the December 2022 Work Program, for a total of \$10.45 million in GEF project financing and Agency fees. All projects submitted were technically cleared and supported. This includes a national project for Cambodia that is supporting agriculture, farmers' livelihoods, and food security in rural communities by scaling up climate resilient technologies and introducing innovative financial solutions, and a global project. The global project, which will be implemented by UNIDO in partnership with Vulnerable Twenty Group (V20), aims to support community level adaptation initiatives in 58 countries that are highly vulnerable to climate change.
- 12. As of March 31, 2023, the LDCF has provided \$12.20 million in support of the preparation of National Adaptation Programs of Action (NAPAs).<sup>24</sup> The LDCF and SCCF completed its support for NAPA preparation in GEF-6, while it continues to support their implementation as appropriate. South Sudan was the last country to submit its NAPA to the

UNFCCC in 2017, bringing the total number of countries that had completed and submitted their NAPAs to 51.<sup>25</sup>

- 13. Cumulative LDCF funding decisions amount to a total of \$1,762.66 million.<sup>26</sup>. Projects support the implementation of priorities defined in NAPAs and national adaptation plans (NAPs), as well as other elements of the LDC work programme (see Figure 2).
- 14. In addition to financing the urgent and immediate adaptation needs of LDCs and the LDC work programme, the LDCF is also mandated to support the NAP process, which is an iterative and ongoing process encapsulating medium and long-term planning for adaptation. As of March 31, 2023, total funding from the LDCF toward LDCs' NAP formulation processes amounts to \$60.33 million. This includes projects in Chad, Democratic Republic of the Congo, Djibouti, Guinea-Bissau, Lao PDR, Niger, Rwanda, São Tomé and Príncipe, and Senegal. This also includes three global projects with LDCF resources amounting to \$13.69 million approved to support the preparation of the NAP process in LDCs, and the implementation of elements of the LDC work programme other than NAPAs. The three global projects to support the preparation of the NAP process have all been fully implemented and financially closed.
- 15. The GCF and GEF have continued to work together to offer streamlined and coordinated support to countries and to avoid overlap, including as related to the NAP process. GCF and GEF coordination on climate change adaptation projects enable countries to move more effectively towards the integration of climate change adaptation considerations across key policies, plans, programs and decision-making processes, in line with guidance from the COP to the UNFCCC,<sup>29</sup> as well as a LDCF/SCCF Council decision to operationalize support towards NAP process.<sup>30</sup>



### **LDCF Resource Access for GEF-8 Period**

16. For the GEF-8 period starting on July 1, 2022, the LDCF initial resource access cap for which each LDC can draw has doubled to \$20 million. Table 3 shows the GEF-8 and cumulative status of LDCF resources accessed by each LDCF, as of March 31, 2023.



# **Agency Involvement in LDCF Projects**

17. Since the LDCF inception to March 31, 2023, 12 GEF Agencies have been involved in LDCF projects and programs. According to the GEF Trustee Report, United Nations Development Programme (UNDP) has the largest share of project funding approvals, with 47 percent, the Food and Agriculture Organization (FAO) at 14 percent and United Nations

Environment Programme (UNEP) at 12 percent, as shown in Figure 3. Other GEF Agencies implementing LDCF projects are Asian Development Bank (ADB), African Development Bank (AfDB), Banque Ouest Africaine de Développement (West African Development Bank, BOAD), Conservation International (CI), International Fund for Agricultural Development (IFAD), International Union for Conservation of Nature (IUCN), United Nations Industrial Development Organization (UNIDO), World Wildlife Fund-US (WWF-US) and World Bank. 33 During GEF-7, progress was made to increase the balanced distribution of LDCF financing among Agencies, which will be further enhanced in GEF-8.

### **CEO Endorsements**

- 18. During the reporting period, nineteen LDCF projects totaling \$98.39 million in GEF project financing were CEO endorsed/approved (see Table 4).
- 19. The revised Project Cancellation Policy that took effect March 1, 2019 has been applied to improve the operational efficiency of the GEF.<sup>35</sup> Under this revised policy, if a FSP has not been submitted for CEO endorsement within 12 months of the date of Council approval or if it has not been CEO endorsed after 18 months, the project may be subject to cancellation. All projects approved in the June 2019 LDCF Work Program and thereafter fall under the revised

Cancellation Policy. The actual time between the PIF approval and CEO endorsement of all FSPs during this reporting period ranged from 8 months to over 3 years, with the average time between PIF approval and CEO endorsement being 24 months.

- 20. In total, 333 projects<sup>36</sup> had been CEO endorsed or approved as of March 31, 2023, including the nineteen projects during this reporting period as reflected in Table 3.
- 21. Since the revised cancellation policy took effect on March 1, 2019, based on information in the AMR, during the reporting period thirteen projects submitted notifications of delayed submission of CEO endorsement request to delay the final date required for CEO endorsement or approval of LDCF projects by invoking *force majeure*. <sup>37</sup>

#### **Expected Results under the LDCF**

- 22. Key expected results of the approved LDCF projects are summarized in Table 4.<sup>38</sup> Full expected results can be found in the results frameworks specific to each project, available in the project documents posted on the GEF website.<sup>39</sup>
- 23. In response to the request made at the 14<sup>th</sup> LDCF/SCCF Council meeting in June 2013, the GEF Secretariat, in its Annual Monitoring Review (AMR) of the LDCF and the SCCF, continues to provide a summary of actual, portfolio-level results of projects that have been completed or that are under implementation. A new AMR, reporting results from the 2022 fiscal year will be presented at the June 2023 LDCF/SCCF Council.<sup>40</sup>
- 24. The LDCF's portfolio of approved projects seek to directly reduce the vulnerability of more than 60.17 million people. LDCF projects are supporting countries in their efforts to integrate climate change adaptation into an expected 3,164 policies, plans, and processes to identify, prioritize, and integrate adaptation strategies and measures. The LDCF also assists countries in laying the groundwork for climate-resilient development by training an expected 2.11 million people to identify, prioritize, implement, monitor and/or evaluation adaptation strategies and measures.

project beneficiaries of LDCF projects are female, and 679,959 of the 1.41 million (48.2 percent) expected people trained are female.

- 26. The LDCF and SCCF results framework has been updated for GEF-8 projects, as presented in the GEF-8 Strategy on Adaptation to Climate Change. Updates include a new core indicator related to private sector engagement, a new core sub-indicator on hectares of coastal or marine area managed climate resilience and tracking of age disaggregation. The updated results framework is used for all newly approved projects LDCF and SCCF projects in GEF-8.
- 27. The two LDCF projects approved in the reporting period are expected to directly benefit 90,000 people (50.0 percent women), bring 20,000 hectares of land under climate resilience, strengthen climate adaptation in 3 policies or frameworks, train 22,000 people (50.0 percent women), and result in 30 private sector enterprises engaged in climate change adaptation and resilience action.28. The GEF Policy on Gender Equality and GEF Policy on Stakeholder Engagement also apply to LDCF projects.<sup>45</sup>
- 29. The following are examples of projects that were CEO endorsed during this reporting period, with a brief description of their expected results and impacts.
- 30. Building climate-resilient livelihoods and food systems in Lesotho (GEF ID: 10793); GEF Agency: FAO; GEF project financing: \$10.00 million; Co-financing: \$40.20 million. The project will enhance climate resilience of landscapes and communities for food and nutrition security through sustainable water management. This will be achieved through strengthening policy and institutional capacities, promoting innovative, sustainable land and climate resilient agricultural water management, and strengthening resilience of agricultural and food value chains. The project is expected to reduce the vulnerabilities of an estimated 40,000 direct beneficiaries and manage 15,000 hectares of land for climate resilience.
- 31. Restoring and Enhancing the Value of Degraded Lands and Forest Ecosystems for Enhanced Climate Resilience in Benin (PIRVaTEFoD) in Benin (GEF ID:10688); GEF Agency: UNDP; GEF project financing (LDCF): \$5 million; Co-financing: \$16.70 million. The MTF project will support the achievement of Benin's Land Degradation Neutrality (LDN) targets through climate risk integrated sustainable land and forest management practices and strengthen the climate resilience of vulnerable populations in the Niger Valley, Alibori Sud-Borgou Nord-2KP and Zou-Couffo agricultural development Areas. The LDCF financing will Strengthen ed national policy, governance and financial frameworks and capacity to implement climate risk informed Sustainable Land Management and Sustainable Forest Management, and climate-proofed sustainable livelihoods contributes to achievement of LDN, Integrated climate risk informed gender-responsive management and restoration of target degraded lands, forests and ecosystems in selected agricultural development areas and communities at pilot sites receive tangible benefits from engagement in diversified, climate resilient and gender-responsive

income generating activities (with supporting value chains that promote LDN). The project will deliver direct adaptation benefits to 48,000 people and increase areas managed for climate resilience by 30,000 hectares. It will mainstream climate resilience in 5 policies and plans, and train over 1,000 people in climate risk management approaches.

### Impacts of the COVID-19 Pandemic

- 32. As the GEF continues to adapt to the evolving impacts the COVID-19 crisis is having on its business, a set of issues have been identified and specific actions have been incorporated in the different phases of the project review cycle of the GEF Trust Fund, LDCF, and SCCF projects. These actions have been developed and continuously updated in active consultation within the GEF Partnership to mitigate COVID-19 risks and ensure efficient and effective design and implementation of LDCF and SCCF resources. Each project is reviewed by applying additional guidance on COVID-19 to ensure that it has identified key impacts, as well as taken into account the risks and opportunities of the pandemic on the project outcomes. This practice has continued into GEF-8.
- 33. Since June 2020, the GEF Partnership has been investigating opportunities and taking actions to ensure GEF investments in climate adaptation contribute to addressing the full effect of the COVID-19 pandemic. This includes analyzing and integrating pandemic associated risks, impacts and opportunities into the business of the LDCF and SCCF. The LDCF and SCCF will continue to deepen its investment in opportunities to mitigate impacts of COVID-19 to deliver climate adaptation and resilience benefits and contribute toward green recovery and building back better.

### **Sectoral Distribution**




Figure 4: Sectoral Distribution of LDCF Projects since Inception

34. Each LDCF project is focused on one or more sectors. Figure 4 provides a breakdown of the cumulative sectoral distribution of all LDCF projects since inception. Agriculture, water, and climate information services are the sectors with the greatest focus among all LDCF projects, followed by the nature-based solutions.

# **SPECIAL CLIMATE CHANGE FUND**

### Pledges and Contributions to the SCCF


- 37. As of March 31, 2023, 16 donors pledged and signed Contribution Agreements or Contribution Arrangements amounting to \$396.17 million. The Trustee has received \$362.82 million in cash receipts to date from these donors, which is equivalent to 91.6 percent of all resources pledged.<sup>46</sup> Figure 5 presents annual SCCF contributions and cumulative resources received by fiscal year.
- 38. Alliance of Small Island States (AOSIS), Ireland, and Switzerland issued a joint appeal at COP27, on November 11, 2022, to encourage al contributors in a position to do so to help mobilize timely support for the adaptation priorities of SIDS, by making voluntary contributions to the SCCF. A pledging session was held on November 15, 2022, at COP 27, in which \$35.0

million was committed for the SCCF, by Denmark, Germany, Ireland, Slovenia, and Switzerland.<sup>47</sup> This marks the first time that Slovenia has contributed to the SCCF.

39. During the reporting period, \$12.53 million in new contributions were received to the SCCF, from Canada, Denmark, Ireland, Slovenia, Switzerland, and the United Kingdom. Funds available to support the Council or CEO decision were \$23.89 million as of March 31, 2023.

### **Progress in SCCF Operations**

40. As of March 31, 2023, cumulative funding decisions by the Council and the CEO amounted to a total of \$365.14 million, according to the Trustee Status Report for the SCCF. Of the total amount approved, \$321.67 million was for projects and project preparation activities, \$31.81 million was for fees, and \$11.66 million was for administrative expenses and corporate activities of the SCCF. <sup>49</sup> There is a total of 94 projects approved under the SCCF since




Figure 6: Annual and Cumulative SCCF Funding Approvals by Fiscal Year as of March 31, 2023 (\$ million)<sup>51</sup>

inception.<sup>50</sup> Annex II presents a complete list of approved projects to date under SCCF-A and B. Figure 6 shows SCCF approvals by fiscal year.

## **Approvals and CEO Endorsements**

- 41. During the reporting period, one new FSP had its PIF approved with \$0.51 million in support from the SCCF. This was an MTF with the LDCF, titled *Vulnerable Twenty Group Funding Programme to Leverage Adaptation by Averting and Minimizing Impacts of Climate Change.*
- 42. Also during this reporting period, two MSPs were CEO approved though the two-step approach. These two projects have a total value of \$0.90 million in SCCF finance. Both projects are MTFs with the LDCF and are supported through the Challenge Program for Adaptation Innovation.

- 43. While the SCCF window A for SIDS received increased support during this reporting period, window B for technology transfer, innovation and private sector engagement continues to be resource constrained. The lack of funds in SCCF window B continues to limit the GEF's programming potential to address climate adaptation priorities, particularly for countries that are not LDCs or SIDS, as well as for the areas of technology transfer, innovation, and private sector engagement.
- 44. In total, 91 SCCF projects had been CEO endorsed or approved as of March 31, 2023, including the two projects that were CEO approved during this reporting period and reflected in Table 6 above.
- 45. The following is the project that was PIF approved during this reporting period, with a brief description of its expected results and impacts.
- 46. Vulnerable Twenty Group Funding Programme to Leverage Adaptation by Averting and Minimizing Impacts of Climate Change (GEF ID 11055, Global, Agency: UNIDO, SCCF financing: \$514,782<sup>52</sup>). This MTF project financed with the LDCF will enhance access to finance for adaptation by supporting the deployment of innovative adaptation solutions. As a dedicated cooperative initiative of 58 vulnerable countries to the impacts of climate change, the Vulnerable Twenty Group (V20) will work through dialogue and action to tackle climate actions that can address the 25.0 percent decline of their economies attributed to climate change. The project will provide resources directly into affected communities of the V20 group's member countries through innovative climate adaptation projects and interventions supported by micro, small and medium-sized enterprises (MSMEs) and civil society organizations (CSOs). The V20

will also mobilize additional resources for addressing loss and damage in its member states, thus contributing to the goal of doubling the adaptation finance for vulnerable countries by 2025. The project will further create and operationalize a V20 Funding Programme (VFP) that will directly support a range of innovative adaptation interventions such as community infrastructure and livelihood asset repair, climate resilient reconstruction and rehabilitation for communities most recently impacted by extreme weather events to build back better standards. This will be achieved through enhanced access to knowledge and building capacity of decision makers and beneficiaries to implement adaptation action, by (i) creating distribution and support channels of adaptation technologies, and services, (ii) generating and disseminating knowledge material and (iii) raising awareness of key stakeholders on climate change vulnerability and availability of climate adaptation technologies and services.

47. There was no new MSP supported by only SCCF that had CEO approval or being prepared for CEO approval during this reporting period. The June 2023 Work Plan is expected to include one project supported by the SCCF that is focused on a SIDS, and one project focused on technology, innovation, and private sector engagement.

## **Agency Involvement in SCCF Projects**




Figure 7: Distribution of SCCF Financing by Agency as of March 31, 2023 (\$ million)55

- 48. As of March 31, 2023, thirteen GEF Agencies were involved in SCCF projects.<sup>53</sup> The World Bank holds the largest share of the portfolio at 26 percent, followed by UNDP at 25 percent, 12 percent by IFAD, and 10 percent by UNEP, as shown in Figure 7.<sup>54</sup>
- 49. No changes in the number of Agencies involved in SCCF projects was recorded during this reporting period. The total share of SCCF resources by MDBs and IFAD remained significant, with 55 percent of all resources.

### **Expected Results under the SCCF**

- 50. By the end of the reporting period, all 91 of 94 SCCF projects have been endorsed or approved by the CEO.<sup>56</sup> Of these projects, 47 have completed implementation.<sup>57</sup>
- Table 7 provides a summary of the quantitative results indicators from SCCF projects. Full expected results are detailed in the results frameworks specific to each project, available in the project documents posted on the GEF website. - 52. Projects approved for SCCF support aim to directly reduce the vulnerability of 8.91 million people. Furthermore, SCCF projects support countries in their efforts to develop or strengthen an estimated 486 policies, plans, and processes that identify, prioritize, and

integrate climate change adaptation strategies and measures. Additionally, SCCF projects train an estimated 219,765 people to identify, prioritize, implement, monitor and/or evaluate adaptation strategies and measures.

53. Since the start of GEF-6 in July 2014, which is when LDCF/SCCF began systematically tracking sex disaggregated data, 1.19 million of the 2.52 million (47.2 percent) expected project beneficiaries of SCCF projects during this time period are female, and 26,789 of the 58,623 thousand (45.6 percent) expected people trained are female.

#### **Sectoral Distribution**

54. Each SCCF project focusses on one or more sectors. Table 8 provides a breakdown of the cumulative sectoral focus on all SCCF projects since inception. Water, agriculture, and climate information are the sectors with the greatest focus among all SCCF projects, followed by the sector of nature-based solutions.




Figure 8: Sectoral Distribution of SCCF Projects Since Inception

# **MULTI-TRUST FUND PROJECTS (MTFs)**

- 55. To date, there have been a total of 41 projects and six programmatic approaches that draw resources from multiple trust funds involving the LDCF and/or SCCF. Of these 41 MTF projects, 10 draw resources from both the LDCF and SCCF, 21 draw from the LDCF and GEF Trust Fund, and 8 draw from the SCCF and GEF Trust Fund.
- 56. The ability to advance integration and mainstreaming of adaptation with support from multiple trust funds is a unique and positive feature of the GEF, as this supports integration and seek synergy across different climate and global environmental dimensions. The GEF Secretariat will continue its efforts to facilitate such programming as appropriate, taking into consideration national needs, opportunities for systemic impact, and programming priorities.

#### IMPLEMENTATION OF GEF-8 STRATEGY ON ADAPTATION TO CLIMATE CHANGE: DEDICATED PROGRAMS

57. The GEF-8 Programming Strategy include a new initiative called the Dedicated Programs, a corporate program that provides targeted support for communications and visibility enhancement, outreach and capacity support for country planning and programming with a focus on enabling access, and organizational learning and coordination.

58. During this reporting period, work continued to further elaborate these Dedicated Programs and to implement activities, as part of the Secretariat efforts for the GEF-8 launch.

# **Dedicated Program I. Communications and Visibility Enhancements**

- 59. The GEF-8 Strategy on Adaptation to Climate Change identifies the need to enhance the profile and visibility of the LDCF and SCCF. This includes development of a robust communications strategy for the funds to meet their growing ambitions and highlight their work and results. Planned efforts to enhance visibility include the elaboration and execution of the communications strategy, which will aim to bolster public and stakeholder awareness about the LDCF and SCCF and the projects they support in LDCs, SIDS, and other climate-vulnerable countries.
- 60. This communications strategy will amplify efforts already underway to create and distribute editorial and social media content related to LDCF- and SCCF-funded projects. This includes broadening outreach by developing and strengthening partnerships with communications counterparts in the climate change and adaptation space, including past Challenge Program for Adaptation Innovation winners. Visibility and outreach efforts related to donor commitments and the outcomes of LDCF/SCCF Council meetings will continue, supported by the monthly GEF newsletter, updated GEF website, and GEF social media channels - using the hashtags #LDCF and #SCCF.
- 61. After the current reporting period and prior to publication of this Progress Report, the GEF Secretariat has taken further action on communicating the value and progress of the LDCF and SCCF. This has included updating the climate change adaptation section of the GEF website and associated content, 66 production of introductory videos to the LDCF and SCCF in English, French, and Spanish<sup>67</sup>, and hiring of a full-time consultant to strengthen communications related to the LDCF and SCCF, and the preparation of the detailed draft communication strategy referenced above.

# Dedicated Program II. Outreach and Capacity Support for LDCF and SIDS Planning and **Programming**

62. Notable progress has been made during this reporting period under the Dedicated Program on "Outreach and Capacity Support for LDC and SIDS Planning and Programming". Of the series of regional programming workshops envisioned for LDCs and SIDS during GEF-8, one took place during the reporting period, discussed below, and another was in advanced stages of preparation. 68




- 63. The GEF organized the first sub-regional adaptation programming and strategy workshop on March 23-24, 2023, in Maputo, Mozambique. It was held back-to-back with the GEF's Southern Africa Expanded Constituency Workshop (ECWs), and was attended by participants from five LDCs (Angola, Lesotho, Malawi, Mozambique and Zambia). This workshop was attended by over 30 participants, of which 48 percent were female. Participants included GEF Operational Focal Points, UNFCCC national focal points, climate adaptation experts from various ministries and national institutions, civil society organization (CSO) representatives, and GEF Agencies.
- 64. The objective of the programming workshops is to help countries strengthen the design of LDCF project concepts for greater adaptation impact, and to enhance access to adaptation finance and enable coordinated programming across various funding sources. The workshop in Maputo covered key topics such as requirements for accessing LDCF and SCCF finance, the LDCF/SCCF project cycle, designing for impact, strengthening the scientific basis of project concepts coordination with GCF programming, and other key topics. The Chair of the LDC Group under the UN Climate process also shared guidance and insights on the adaptation landscape.
- 65. The GEF agencies shared lessons from implementation of projects through Learning Stations that showcased an LDCF project in Mozambique and provided participants the opportunity to learn about the project activities, success stories, lessons learned, and challenges. The interactive session also allowed participants to reflect and share experiences from other projects, highlighting achievements, challenges, and sustainability of project interventions. The workshop was delivered through interactive sessions including videos, PowerPoint presentations, online polls and project concept brainstorming sessions among participants. Participants gained insights on the entire project development process. Figure 10 below shows positive feedback received from the participants on the value of the workshop. All participants expressed a strong interest in attending similar workshops in the future.
- 66. Participants engaged in vibrant discussions about the sustainability of farmer field schools, early warning systems (including building technical capacity for operations and maintenance), and safeguarding adaptation projects from the impacts of imminent climate disasters, amongst other topics.

67. Participants were also asked about their interests in specific themes related to climate change adaptation. The results of their responses showed that many of the participants were interested in nature-based solutions (76.2 percent), followed by climate resilient infrastructure (71.4 percent, and climate adaptation investment (66.7 percent). This insight provided by participants will help define areas of focus for further learning activities.

#### **Dedicated Program III. Organizational Learning and Coordination**

- 68. With almost 500 approved projects, many of which have been completed or are under implementation, the LDCF and SCCF portfolios provide an invaluable resource of climate change adaptation experiences and learning. In the GEF-8 period, the Secretariat will enhance portfolio- and partnership-oriented learning. The objective of this dedicated program is to enable the fund- and portfolio-level learning by creating, acquiring, and sharing knowledge and insights, with a strong focus on projects in the field. This learning gained will drive ongoing design and performance improvements of the LDCF and SCCF.
- 69. An implementation plan and small technical advisory group will be formed to ensure most critical priorities and emerging needs for climate adaptation learning are addressed. The advisory group will build on the series of consultations that took place during the process of developing the GEF-8 LDCF/SCCF Programming Strategies, as well as the regional workshop series as part of Dedicated Program 2. Advisory group members will be selected based on their thought leadership and expertise in key GEF-8 themes, focus areas, and programming entry points. Attention will also be given to ensuring an appropriate balance of regions and genders, as well as representation of youth, indigenous peoples, civil society, and private sector actors. Other funds that support climate change adaptation, such as GCF, Adaptation Fund, and Climate Investment Funds may also invited to the advisory group, to learn from their experience as well as to share LDCF and SCCF learning with them.
- 70. During this reporting period, GEF OFPs, UNFCC OFPs, other country representatives, and thematic technical specialists, provided initial reflections on priorities for learning focus areas through regional workshops as part of Delivery Program II outlined above, and other forums. Topics that were highlighted in these initial consultations as being of particular interest included nature-based solutions, climate resilient infrastructure, climate adaptation investment plan development, and opportunities for catalyzing private sector engagement. Learning topics will be further identified at other regional workshops and will serve as input to the advisory group in defining learning focus areas.
- 71. Learning focus areas will be determined based on criteria such as importance in GEF-8 period, significance and urgency of knowledge gaps, and potential areas of importance looking into GEF-9 period. For example, learning focus areas may include, but not limited to: national climate adaptation investment plan development; policy coherence for climate adaptation and resilience; climate adaptation impact measures and monitoring agriculture, food security and health; nature-based solutions; early warning and climate information systems; climate resilience of energy production, transmission, and storage; gender considerations for climate adaptation and resilience; locally-led adaptation; climate resilience debt swaps; climate resilience impact bonds, investment funds for climate adaptation and resilience; green banking for localized climate adaptation and resilience; and climate resilience insurance. Learning and knowledge sharing activities will be carried out with a strong view to enabling south-south learning.

72. Findings will be shared through white papers, blogs, journal articles, regional workshops, and technical clinics through Dedicated Program 2, as well as UNFCCC and other global and regional fora, with close collaboration and support from the Dedicated Program 1 on Communications and Visibility Enhancement. Learning and knowledge sharing activities will be carried out with a strong view to enabling south-south learning.

#### **CHALLENGE PROGRAM FOR ADAPTATION INNOVATION**

- 73. The Challenge Program for Adaptation Innovation was launched in 2019, in alignment with the approved adaptation programming strategy for GEF-7. The objective of this program is to catalyze innovation to harness the power of private sector actors for achieving adaptation results. The Challenge Program aims to test and validate potentially scalable, bankable, or otherwise fundable investment approaches, business models, partnerships, and technologies.
- 74. The Challenge Program for Adaptation Innovation has been successful in attracting and engaging a range of new partners with whom the GEF had not yet been able to directly partner with through conventional programming. Several private sector and other partners involved in this program are engaging directly for the first time in a GEF project. The Challenge Program has served as a model for design of the Small Grants Program and the Competition window under the GEF Trust Fund for the GEF-8 period.
- 75. In total, 19 winning projects have been invited to partner with GEF Agencies in submitting projects, consistent with GEF standard policies and procedures. All projects supported through the first round of this program are under implementation. Of the ten projects selected through the second round, four were CEO approved by the end of this reporting period. At the time of publication of this report, an additional five projects had been CEO approved.
- 76. A project was included in the June 2023Work Program being considered by the LDCF/SCCF Council, titled Amplifying the Impact of the GEF "Challenge Programme for Adaptation Innovation" through Learning and Knowledge Management. This project will strengthen innovation and the role of the private sector in accelerating climate adaptation innovation through learning and knowledge management. The project will capture and share learning from projects supported through the Challenge Program for Adaptation Innovation, to strengthen design and implementation of other LDCF and SCCF projects, including but not limited to the Challenge Program for Adaptation Innovation, as well as help advance the practices of engaged stakeholders more broadly. Supported by a central website and learning strategy, three communities of practice will be managed by key partners throughout the life of the project to overcome timely challenges and opportunities for innovation and private sector engagement in climate adaptation. These will focus on design, capitalization, and management of investment funds; MSME incubation and acceleration; and impacts and measures metrics with private sector perspectives.
- 77. The GEF-8 Strategy for Climate Change Adaptation calls for a four-fold increase in LDCF and SCCF support to climate adaptation innovation and private sector engagement through this

challenge program up to \$80.00 million, to be financed equally by the LDCF and SCCF, subject to availability of resources.

# **OVERVIEW OF CONTRIBUTIONS, COST STRUCTURE AND VISIBILITY**

- 78. The tables presented in this section provide an analysis on contribution levels and diversification, efficiency of cost structure, and visibility of the LDCF and the SCCF. This information is based on a fiscal year cycle, and therefore is updated in each Progress Reports presented to the LDCF/SCCF Council held in November or December of each calendar year. As such, the figures below were presented in the Progress Report to the 33<sup>rd</sup> LDCF/SCCF Council.<sup>69</sup>
- 79. The number of media stories and mentions in the media of LDCF and SCCF increased to a total of 975 in FY22 from 240 in FY21, which represents an increase of 406.3 percent. With regards to the SCCF specifically, it is noteworthy that although this trust fund has been resourced constrained in recent years, it received the attention of 325 media stories in FY22. This media attention for SCCF projects suggests there may be strong visibility value to be gained if this trust fund would become well-funded.
