JOINT SUMMARY OF THE GEF COUNCIL CO-CHAIRS

OPENING OF THE MEETING

1. The meeting was opened by Carlos Manuel Rodriguez, Chief Executive Officer/Chairperson of the Facility. Dawda Badgie, Council member for Burkina Faso, Cabo Verde, Chad, Guinea-Bissau, Mali, Mauritania, Niger, Senegal, and The Gambia, had been designated as Elected Chairperson for the calendar year 2024 by decision 29/2023 adopted on December 19, 2023.

ADOPTION OF THE AGENDA

2. The Council adopted the provisional agenda set forth in document GEF/C.66/01.

DECISIONS APPROVED

3. The Council approves the following decisions with respect to its agenda items:

4. The Council, having considered document GEF/C.66/03, *The GEF Monitoring Report 2023*, welcomes the report and continued implementation of the GEF-8 Results Measurement Framework.

Decision 02/2024 *Work Program for GEF Trust Fund*

5. The Council, having considered document GEF/C.66/04, *Work Program for GEF Trust Fund*, approves the Work Program comprising 46 projects and programs, subject to comments made during the Council meeting and additional comments that may be submitted in writing to the Secretariat by March 6, 2024¹.

6. Total GEF resources approved in this Work Program amounted to \$916.1 million, including GEF project financing and Agency fees. The Work Program is comprised of the following Project Identification Forms (PIFs) and Program Framework Documents (PFDs):

55. With respect to any PIF approved in this Work Program, the final project document will be posted on the GEF website for information after CEO endorsement. If there are major changes to the project objectives or scope since PIF approval, the final project document shall be posted on the web for Council review for four weeks prior to CEO endorsement.

Decision 03/2024

Streamlining the GEF Project Cycle

56. The Council, having considered document GEF/C.66/08/Rev.03, *Streamlining the GEF Project Cycle*:

(a) approves:

- i. An increase in the cap for Medium-Sized Projects from US\$ 2 million to US\$ 5 million,
- ii. Require Mid-Term Review for projects above US\$ 2 million,
- iii. Amendments to the Project Cycle Policy as outlined in Section II, and

(b) requests the Secretariat and an ad hoc working group of interested Council Members and Alternates equally representing donors and recipient countries, to elaborate additional measures for streamlining the GEF project cycle, taking into account ongoing efforts to enhance coordination and harmonization across the climate and environment funds, in consultation with GEF Agencies, GEF Focal Points and others as appropriate, for consideration by Council at its 67th and 68th meetings.

57. The Council, having considered document GEF/C.66/11, *UNDP: 2023 Third Party Review of Minimum Fiduciary Standards*:

- b) Notes the findings of the Third-Party Review of the United Nations Development Programme (UNDP) Compliance with the GEF Minimum Fiduciary Standards Report November 2023 confirming the UNDP self-assessment and full compliance with GEF Minimum Fiduciary Standards.
- c) Notes that the additional requirements related to UNDP described in Decision 26/2021, to be discontinued in December 2023, are no longer needed at this time.

Management Response, takes note of the related evaluation recommendations and endorses the management response to address them.

64. The Council, having considered document GEF/C.66/09, *the Gap Analysis of GEF Funded Activity and engagement in Fragility, conflict, and violence-affected states*, and taking into account ongoing efforts to enhance coordination and harmonization across the climate and environment funds, requests the GEF Secretariat to proceed with the proposed actions.

Decision 12/2024 *Gap Analysis of GEF Policies and Key Social Inclusion Issues*

65. The Council, having considered document GEF/C.66/10, *the Gap Analysis of GEF Policies and Key Social Inclusion Issues*, requests the Secretariat to present to the 67th Council, for decision, a timetable outlining when the policies concerning highlighted areas will be modified. The proposed modifications will take into account ongoing efforts to enhance coordination and harmonization across the climate and environment funds.

Decision 13/2024*Relations with the Conventions and Other International Institutions*

66. The Council, having considered document GEF/C.66/05, *Relations with the Conventions and Other International Institutions*, welcomes the report and requests the GEF network to continue to work with recipient countries to reflect the guidance and national priorities in their GEF programming and activities.

Decision 14/2024*Initial Guidelines for Enabling Activities and Ratification Support Projects for the Agreement under the United Nations Convention on the Law of the Sea on the Conservation and Sustainable Use of Marine Biological Diversity of Areas Beyond National Jurisdiction (BBNJ)*

67. The Council, having considered document GEF/C.66/07, *Initial guidelines for enabling activities and ratification support projects for the Agreement under the United Nations Convention on the Law of the Sea on the conservation and sustainable use of marine biological diversity of Areas Beyond National Jurisdiction (BBNJ)*, approves the initial guidelines set forth in the document and requests the GEF Secretariat to implement them for the funding of ratification support and implementation readiness activities for the BBNJ Agreement.

Decision 15/2024*Amendments to the Rules of Procedure for the GEF Council*

68. The Council, having considered document GEF/C.66/06/Rev.01, *Amendments to the Rules of Procedure for the GEF Council*, adopts the updated rules of procedure as included in Annex II. This supersedes all previous versions of the Rules of Procedure for the GEF Council.

69. The Council, having considered document GEF/C.66/18, *Report of the Selection and Review Committee*:

a) Agrees with the SRC's assessment of the GEF CEO's performance for Fiscal Year 23 (July 1, 2022, to June 30, 2023) and its recommended performance rating. The World Bank will provide its standard salary increase, in accordance with the World Bank's Merit Increase Matrix. The Council requests the SRC to communicate this decision to the World Bank Human Resource Department.

b) Takes note of the SRC's recommendation to the Council to reappoint Mr. Carlos Manuel Rodríguez Echandi for a second term period as GEF CEO.

c) Agrees to consult their constituencies and provide their views of Mr. Carlos Manuel Rodríguez Echandi's reappointment to the Selection and Review Committee by March 31st, 2024.

d) Agrees with the SRC's assessment of the GEF IEO Director's performance for Fiscal Year 23 (July 1, 2022, to June 30, 2023) and its recommended performance rating.

The World Bank will provide its standard salary increase, in accordance with the World Bank's Merit Increase Matrix. The Council requests the SRC to communicate this decision to the World Bank Human Resource Department.

e) Takes note of the Fiscal Year 24 performance objectives for the GEF CEO and IEO Director and requests the SRC to present the performance evaluations of the GEF CEO and IEO Director at the 68th Council meeting.
