Capacity Building Interventions

Now: interventions that can transform the space for "Paris Agreement-style capacity building"

- Benefit capacity-building across the board
- Globally as well as on a country-by-country basis.

Aim to help:

- countries build capacity,
- recipient countries select best practice CB activities,
- donors select best practice CB,
- CB activities to be more rigorous and better coordinated
- Accountability of CB interventions
- Recipient countries be self-sustaining



Climate Capacity Day

Modeled after CIFOR's Forest Day (now Global Landscapes Forum): helped rapidly evolve REDD+

- Driving innovation and transformation in the space
- Spotlighting the importance of capacity building to media and other actors

Coordinating the space, mid-session at COP

An adaptable venue: high level discussions, networking events, side events, discussion fora, example workshops, etc.

Outcome: bringing together CB practitioners, donors, recipient countries, etc.



Evidence-based Reports and Research

- At present: minimal evidence-based CB reports or research
- No widely accepted definition or typology of "capacity building" or "capacity needs assessment"
- Need for thoughtful construction of frameworks that will assess effectiveness, allow for accountability, standardize capacity building
- Applying the scientific method to climate change capacity building
- Outcomes: capacity building practitioners can conduct activities more effectively, create accountability and means of assessing success



Example Capacity Building Reports

- "Scaling for solutions: lessons learned from capacity building for public health (e.g. malaria)"
- "Tracking transparency capacity building efforts: comparisons of monitoring and evaluation (M&E) tools."
- "Teaching it right: developing standards for capacity building from evidence-based adult learning research."
- "Quantifying the capacity gap: putting numbers to existing in-country capacity and imminent capacity needs under the Paris Agreement."

- 200 years combined experience in capacity building


Goal: Transformed capacity building

- Coordination between actors



- 3. Nurture and build embedded incountry professional communities
- 4. Broaden the scope of stakeholders for country MRV activities
- 5. Establish a common core of learning and professional development activities

- 6. Use smart IT tools and innovative mentoring processes
- 7. Invest in pilot projects
- 8. Integrate capacity building with national priorities (e.g. energy security, health and poverty).
- 9. Develop new and embed climate knowledge in existing academic programmes (e.g. engineering, accountancy, biotechnology)
- 10. Provide experts with a forum for discussion
