Joint Statement on the InsuResilience Global Partnership

To be communicated on Tuesday, 14 November 2017, 1:15 pm, at the COP23 Presidency Event “Towards a resilient future: Frontiers of risk sharing”, COP23 site, Bonn Zone, Room 8

We, the signatories of this joint statement, are joining efforts to develop the InsuResilience Global Partnership on Climate and Disaster Risk Finance and Insurance Solutions¹.

The vision of the partnership is to strengthen the resilience of developing countries and protect the lives and livelihoods of poor and vulnerable people against the impacts of disasters.

The central objective of the Partnership is to enable more timely and reliable post-disaster response and to better prepare for climate and disaster risk through the use of climate and disaster risk finance and insurance solutions, reducing humanitarian impacts, helping poor and vulnerable people recover more quickly, increasing local adaptive capacity and strengthening local resilience. This complements ongoing efforts in countries to avert, minimize and address climate and disaster risks.

We build on the G20, V20 and G7 Communiqués of 2015² and 2017³ in which we laid the ground for the InsuResilience Global Partnership.

We invite partners from the G20, the V20 and other countries, international organizations, civil society, the private sector and academia to engage and contribute to the Global Partnership according to their respective capacities. The Partnership is inclusive and open to stakeholders aligned to the vision and objective of the Partnership.
