Thank you for the feedback and we have revised Section 1a. Part 2 in the PIF accordingly - please refer to the attached word version of the PIF where all revisions are highlighted in yellow. Our response to the requested information are as follow:

## Component 1:

a) The review report will contain updated vulnerability and adaptation related information and address the existing investment gaps in four landscapes to support the national country investment plan for the environment, forest, and climate change (EFCC) sectors. (Please see the output 1.2.1. and the indicator under outcome 1.2)

b) This will be ensured by the capacity building program of the Govt. entities. The capacity building program will be detailed in PPG period and as based upon planned technical and capacity needs assessment, and in close consultation with Govt. entities and related partner (ongoing and planned) CCA programming.

### Component 2:

c) A combined early warning system will be developed and operationalized in collaboration with Bangladesh Meteorological Department (BMD), and Flood Forecasting and Warning Centre (FFWC) of BWDB. Please *refer to 2.1.2* component output description in the revised PIF, *page 18.* 

d) The major objective of the innovation incubator is mentioned under *outcome 2.2, page 18*. More detailed analysis is planned and is anticipated to utilize the PPG phase for supported agri-business and investment models, technical expertise and stakeholder consultations to further identify and pinpoint innovation incubators.

e) Yes, prioritized value chains (e.g. for select high value products and niche markets, please see *Annex D* for specific products under discussion) will be implemented in collaboration with private entities to support the resilient livelihood activities mentioned in Annex D (see attachment).

### Component 3:

Systematic consultations with superstore chains have not been conducted during the PIF preparation stage. However, few selected village super markets were consulted regarding the proposed approach. Based on these consultations the PIF preparation team believes there is a market demand and profitable business opportunities involving the climate resilient livelihood commodities listed in Annex D. Systematic consultations with superstore chains will be conducted during the PPG stage. We are confident that superstore chains will continue to be interested to engage further in the project's approach.

3) After further discussion, the gender ratio has been revised to ensure 50/50 balance among the direct beneficiaries – this is also reflected in the updated excel file. Through its market-based interventions aimed at strengthening agribusiness and value chain development, particularly to improve the livelihoods of women, the project will strive to ensure that women constitute 50% of the direct beneficiaries. With regards to CCA Core Indicator 4 on the number of people trained (in this case government staff), we remain with a 40% women and 60% men ratio given that women still remain underrepresented in the inter-ministerial agencies targeted by the project.

## Secretariat Comment at PIF/Work Program Inclusion

#### YS, 4/19/2019:

Yes. Bangladesh is increasingly facing climate change stress that is affecting its natural systems, population, economy and wellbeing of poor communities, due in part to its low-lying geographical location. The country frequently experiences floods, storms, tropical cyclones, droughts, sea level rise, hydro-morphological changes, river bank erosion, and salinity intrusion. The increased intensity and frequency of extreme weather events combined with low-socioeconomic development pose serious challenges to both human and ecological coping mechanisms, resulting in high vulnerability across landscapes that the proposed project will focus on: (i) High Barind Tract; (ii) waterlogged areas; (iii) saline-prone areas; and, (iv) Chittagong Hill Tracts. Additional barriers articulated are: i) Limited institutional and human resource capacity and cross-sectoral collaboration on vulnerability reduction; ii) Dearth of decision support systems; iii) Lack of appropriate adaptation technologies and practices to reduce vulnerability of smallholders; iv) Limited financial resources and market support for enhancing resilient livelihoods; and, v) Low awareness of climate risks and adaptation measures among local stakeholders, and lack of effective knowledge management, monitoring, and evaluation.

FI & YS, 4/19/2019:

Yes. The proposed project is structured around four components:

Component 1 will strengthen cross-sectoral collaboration and enhance national institutional capacity to mainstream and foster climate resilience.

Component 2 will promote climate vulnerability decision-support systems, climate resilient research and innovation and build foster climateresilience and adaptation knowledge, climate innovation, and build awareness about climate change vulnerability, climate-resilient livelihoods. For example, it will share information to national stakeholders and local people on hydrological and meteorological issues through a website, mobile app, and SMS. In addition, long-term value chain adaptation plans will be developed to manage anticipated shifts in the suitability and viability of key farming systems in targeted landscapes based on integrated climate and agroecological zone models.

Component 3: will formulate local gender-differentiated participatory adaptation plans, implement innovative financial solutions and investment models, and support climate resilient livelihoods. Here, market opportunities will also be created by linking private investments and superstore chain in climate resilient livelihood and adaptation measures to promote the crops. It will also include activities designed to establish public-private partnership agreements to finance climate resilient and adaptive solutions in the four selected vulnerable areas based on action plans developed (which will examine sustainable production, storage, improved and low-cost agricultural inputs, transportation, improved value chain & SMEs, stronger access to markets, etc.).

Component 4 will ensure the monitoring and evaluation framework for different activities, concentrate on effective knowledge management for M&E, and raise awareness about climate change vulnerability and adaptation technologies among vulnerable communities and the public and private sectors.
